4. That no part of the income from the institution is being and will be directed to any individual in the Trust/School Management committee or to any other person or entity. The saving, if any, after meeting the recurring and non-recurring expenditure and contributions to developmental, depreciation and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.
5. That school is not paying any charges towards using name, motto, logo, or any other non-academic activities to any other institution, organization, or body.
6. That school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
