CONSTITUTION OF THE TRUST - 30th of September 1967

1. The Trustees form the Board of Trustees of "MARUTHI EDUCATION TRUST".
2. The Author has this day transferred and given unto the Trustees a sum of Rs. 1,000/- [Rupees One thousand only] to be held upon Trust together with all the income arising therefrom and all the accumulations and accretions thereto for the intent purpose and objects herein contained.
3. Trustees remain as trustees for their life time and the number shall not be less than five and more than seventeen.
4. Any trustee may retire at any time without assigning any reason but with a written notice to the Secretary.
5. The Board of Trustees may enroll new members in place of those that retire subject to the condition laid down in clause[2] stated above.
6. The Board of Trustees shall meet at least twice a year and may meet more frequently if need arises.
7. All decisions shall, as far as possible, be unanimous. In case of difference of opinion decisions may be taken by simple majority and the decision is binding on all the Trustees.
8. The Board of Trustees may accept contributions from individuals who desire to help the Trust in its activities. The secretary shall maintain proper accounts for the income and expenditure and submit accounts for scrutiny and approval of the Board of Trustees towards the end of March every year.
9. A savings Bank Account may be opened in a Bank for managing the finances of the Trust. The account may be operated by the Secretary and the Chairman of the Trust jointly.
10. The Trust money should be used only for the fulfillment of the educational objectives of the Trust and for no other purpose.

11. The Board of Trustees have the power to take all decisions connected with financial, administrative, academic and other matters that ensure proper fulfillment of the objectives of the Trust.

12. When the Board of Trustees feel convinced that it is no longer possible to undertake activities that fulfill the aims and objectives of the Trust they may wind up the Trust by a majority decision, if unanimity is not possible. They have the power to decide the disposal of assets, if any, at the time of winding up, in any manner they deem fit, for any educational purpose.
