



Our last newsletter in August talked about drought and scorched grass, well those days are certainly well behind us and the mud and rain have turned up as reliably as the bills do!

The last few months have seen worrying (if not predicted) lack of support from the government and inheritance tax is still a major concern for a lot of farms. We understand these challenges, and we are planning our events at the moment with a focus on what can be done to make farms more efficient and reduce costs.

Beef prices have remained high with some incredible results seen at the markets. The milk price has dropped however and we will see further drops in the months to come. At present there is 6% more milk than is needed nationally, we are aware milk price predictions are looking at 37ppl but Cornwall will always do slightly better than elsewhere as milk production is dominated by processing and not liquid milk. Our advice would be to make sure that you are maximising returns on butterfat, protein, cell count and bactoscan, identify cows that could be dried off and or sold as culls (although supply and demand of cull cows going into the abattoirs could become an issue if too many are being culled). We have also been working with an increased number of farms on slurry storage and this is something that cannot be avoided but that comes at huge financial cost.

As the year starts to draw to a close, people often have tendency to reflect. Reflections from Farm Cornwall? It's been a very busy year, we have greatly enjoyed working with familiar faces and meeting new ones too, and we will continue to stand behind our farms and support and champion them in 2026 - Farm Cornwalls 25th anniversary year!

Grants and funding update

This is a pretty easy update - there are no grants or funding opportunities open! Capital grants is shut, SFI is shut. The government made a last minute announcement that those in expiring Mid Tiers would be able to extend their agreements by a year, in recognition that there is no replacement scheme available for them to enter. We have heard nothing about if/when SFI will reopen.

The annual Mid Tier payments are starting to come through from early December. If your claim is straightforward with no issues you should receive it all in December. If some outstanding issues, RPA aim to pay 75% of the total amount in January while they sort the issue. If you don't receive anything by the end of January, it would be advisable to contact RPA if you have not heard from them.

If you were offered a FETF grant, be aware that some suppliers are struggling to meet the demand for the specified equipment. You may need to look elsewhere.

A well deserved award for Wendy

I don't believe this happens in other areas so effectively and again shows that Cornwall continues to lead the way. What do Farm Cornwall do? Part Two!

We often hear people say "I had no idea Farm Cornwall did that", so we thought it might be useful/interesting for us to give some examples of the work we have been doing over the past year. Every day is different for us and every farm is different, but the aim is always to support the farm to provide a positive outcome.

Mental Health Support

Problems in a farm business often go hand in hand with health problems – both physical and mental. There is no underestimating the pressures that farming life can put on everyone in a family. All of our outreach team are Mental Health First Aiders and trained in ASIST (suicide intervention), and we encourage everyone to speak up, whether you are worried about your own health or someone else. We have professional counsellors and mental health resources that we can put you in touch with, and there is now a dedicated community mental health service for the farming community in Cornwall.

Succession Planning

It's never too early to start thinking about succession planning and having a conversation with your family about what will happen when you retire. Who will take over from you, and do they want to? Who will live where? What are the partnership and tenancy agreements? It can be a relief for everyone involved to know what the future will hold and having a plan can minimise the impact if a crisis happens.

Mediation

When there are disputes or disagreements between family members or business partners it can be useful for an impartial third party to come in to discuss the issues and mediate to achieve a resolution. This can help to take the business forward and avoid permanent damage to important relationships.
