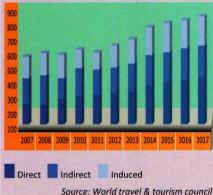
Current Scenario

Tourism is a rising industry in Bangladesh comprised of 3.0% of the total GDP in 2019. The government has allocated Tk. 34 billion in FY 2019-20 in Civil Aviation and Tourism Ministry which is more than double of the allocation of last fiscal year. It indicates that the government of Bangladesh is giving importance to the Tourism Sector.

The importance of Tourism Industry

Bangladesh: Total Contribution of Travel & Tourism to GDP



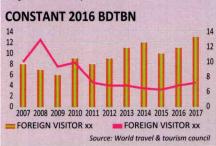
Bangladesh: Visitor Exports and International Tourist Arrivals

Tourism Policies in Bangladesh

Some highlights of National Tourism Policy-2010 for Investors:

- To create better communication between government and private tourism related organizations;
- To create a tourism friendly environment in Bangladesh and to promoteits tourism potential to both local and foreign nationals;
- To develop human resources for tourism sector by creating training facilities and providing them with proper guidelines;
- To attract tourists by maintaining quality tourism services
- To research on tourism industry, to survey international markets and to analyze the data.

The Potential of Bangladesh Tourism Industry

There is endless natural beauty in Bangladesh. Mountains, colorful tribes, Sundarbans theworld's largest mangrove forest, Cox's Bazar the longest seaside and other natural, historical, archaeological sites are the tourist attractions of this country. Proper utilization of the country's natural and historical tourist attractions can open the door to a great deal of foreign exchange.

Country's infrastructure will be developed significantly. More roads and highways will be built. More hotels and restaurants will be established. Rail connection between Cox's Bazaar and Chittagong will be developed soon. After infrastructure, developing superstructures like hotels, motels, inns, restaurants, amusement parks, theme parks are also important for tourists in the destinations. Besides, theme parks, game zone, sports zone like parasailing, paragliding, scubadiving etc. needed to be established adventurous tourists. Bangladesh, therefore, requires huge investment in this sector.

The tourism industry may be one of the major sourcesof earning foreign currency. Some 840,000 foreigners visit Bangladesh annually; in contrast, 13,700,000 domestic tourists visit the same spots annually.

Tourist spots in Bangladesh

Tourist spots in Bangladesh are not concentrated in any particular place. Instead, they are scattered throughout the country.

Jaflong:

Jaflong is one of the best natural tourist spot in Sylhet. It is situated at the borderbetween Bangladesh and the Indian state of Meghalaya. Tourist can learn something from thelifestyle of Tribe Khasia in Jaflong.

Ratargul:

Ratargul is a fresh water swamp forest situated in Sylhet by the river of Goain. The water comes here from the adjacent Goain River. The flavor of Amazon forest is available there.

Madhabkunda waterfall:

This is one of the largest waterfalls in Bangladesh. It is situated in Moulvibazar District. On the way visitors can see the greenish beauty of tea garden and the hills. Rubber and lemon plantations form a beautiful landscape.

Satchori National Park:

This Park is in Habiganj District. Wildlife in this park is rich.

Bisanakandi:

Bisanakandi is situated at Bangladesh-India border in Sylhet. It is a landscapebeauty among gardens and hills. Winter is not a suitable time to visit Bisanakandi due tomechanized mining and stone-laden Boats and Lorries.

Sreemangal:

Sreemangal is famous for the largest tea gardens of world. Most of the tea estatesare in Sreemangal. It is called "The land of two leaves and a bud". It is known as the tea capitalin Bangladesh. Bangladesh Tea Research Institute (BTRI) and Tea Museum are function ingthere.

Lawachara Rain Forest:

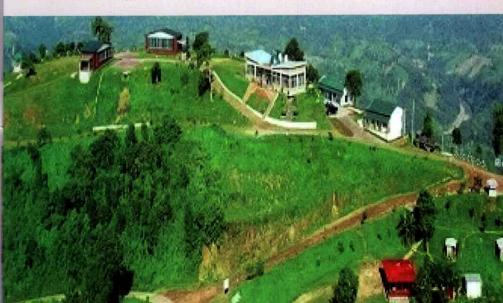

Jatiyo Sritishoudho is the symbol in the memory of sacrifice of all thosewho gave their lives in the Bangladesh Liberation War of 1971.

Tourism economic zone

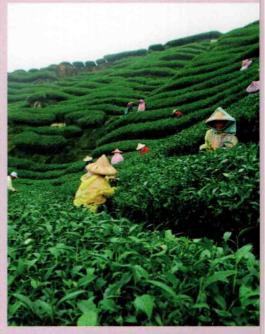
Three tourism parks at Cox's Bazar district named Naf Tourism Sabrang Tourism Park, and Sonadia Eco-Tourism Park is being set up. Sabrang Tourism Park willbe the first exclusive tourism park in the Cox's Bazar district encompassing an area of 1,027 acres. Sonadia Eco-Tourism Park in Maheshkhali is developing on 9,467 acres of land. The proposed three tourist parks are expected to raise the country's position on the tourist index to 99th from the existing 127th position. To support the industry entrepreneurs BEZA is set tooffer a 100 percent tax exemption for the first 10 years, followed by 70 percent and percenttax exemptions in the 11th and 12th year respectively in the tourism park.

Domestic aviation growth

The number of domestic air passengers in Bangladesh has increasedby about 64.73 percent during 2019 compared to five years earlier. In 2013, the number ofdomestic air travelers was 600,000 which has increased to more than one million in 2019 and expected to increase to 21 million in 2035. At the same time, in 2013 a total of 12,526 flights to different domestic routes used to operate and in 2019 the number has increased to 38,057. The healthy growth of air connectivity in the domestic market is also an indicator as well as opportunities for the tourism industry to grow further.

Business tourism

There are approximately 30,000 foreigners living in Bangladesh forprofessional reasons. In addition, the number of foreign visitors has increased by 24 percent in 2019 compared to last year, resulting in an entrance of more than 100,000 foreigners every year. Unfortunately, only five percent of them come for the sole purpose of traveling. there Hence, is a tremendous potentiality to divert the business tourists toward Bangladesh recreational tourism activities through promoting the sector correctly.





Luxury hotel growth

With a 24 percent year on year growth of foreign entrance the demandfor upscale hotel rooms has increased too. It is estimated that the supply of upscale room will increase to 140 percent by 2021. In Cox's bazar there are plenty of hotels and motels. But inother destinations like Kuakata, Rangamati, Khagrachari very few quality hotels are established. So investors can invest in these areas.

Religious tourism

An estimated 300 to 330 million pilgrims visit the world's key religious sitesevery year. Bangladesh can become one of the prominent destinations for religious tourism ispromoted correctly.

Medical tourism

Bangladesh medical tourism is developing as a niche market over severaldecades mainly in the areas of non-mainstream non-surgery and treatment procedures likeIndia and Nepal. The country has a traditional reputation in areas of medical tourism thatcovers herbal, homeopathy Ayurveda medicines. Unani and the tourism world isstill However, unaware of the services, benefits and medical tourism offering of Bangladesh.

Cross country tourism

Bangladesh has the potential to attract global tourists especially from the western countries visiting India, Nepal, and Myanmar by offering its attractive locations and services as an extended destination.

New emerging inbound destinations

There are over 700 spots of tourist interest in the countrywhich include nature-driven ones like sea beach, green valleys, forests, archaeological and historical sites, iconic religious places, cultural events, and man-made wonders. At the sametime, with increasing young tourists who possess a high interest in exploring new areas theactivity around domestic tourism has been increasing rapidly.

Blue economy initiatives and growth opportunities

The marine and coastal environment also constitutes a key resource for the important global tourism industry and expanding the domain of nature-based tourism. Globally, coastal tourism is the largest market segment that represents percent of world GDP five contributes to six to seven percent of total employment. Coastal tourism can attracted through beach-based recreation and tourism, tourist activities in proximity to the sea, marine boating including yachting and watersports activities and many more.

Branding around value destination

Bangladesh is a low cost destination with countless untapped treasures for travellers and backpackers. There are numerous options for an affordable hotel along with inexpensive public transportation such as bus, train, ship, and rickshaws to go from one destination to another. With a diverse and exotic cuisine that is remarkably cheap, it is no wonder Bangladesh is one of the top destinations to visit in 2019.

Internet and online startups

Digital technologies have connected the tourism industry on aglobal level and helped to become a crucial ally for sustainable development. With the tourismtrend going up in Bangladesh, a new breed of companies, enabled with technology, enteringthe market to grab this growing demand. Vromon, Tripping and Jovago are such online startups who are assisting in choosing a travel destination, book hotels, choose from multiple tourpackages, book other services and many other services.





There is no shortage of tourist attractions in Bangladesh. The country has everything a tourist wants. At present, Bangladesh has limited tourism facilities for domestic and foreign tourists. Because of both the public and private sectors, the investment in this industry is less than the demand. As a result; Bangladesh's success in the tourism industry in the international context is minimal. But the potential of Bangladesh in the tourism industry is very bright. The tourism industry of Bangladesh can be one of the major sources of investment and foreign exchange earnings.
