

## Lagrange Raffle Terms

Welcome, and thank you for your interest in Lagrange Foundation, a Cayman Islands foundation company, ("Lagrange," "we," or "us") and the raffle being held for prizes (the "Raffle"). These Terms are a legally binding contract between you and Lagrange regarding your participation in the Raffle. These Raffle Terms are supplemental to, and incorporate by reference, our Terms of Service available at <https://www.lagrangefoundation.org/terms-of-service> ("General Terms" and, collectively with these Raffle Terms, the "Terms"). Defined terms used but not defined herein have the meaning set forth in the General Terms.

### PLEASE READ THE FOLLOWING TERMS CAREFULLY:

BY CLICKING "I ACCEPT," OR BY PARTICIPATING IN THE RAFFLE, INCLUDING BUT NOT LIMITED TO BY LINKING A WALLET (AS DEFINED BELOW), YOU AGREE THAT YOU HAVE READ AND UNDERSTOOD, AND, AS A CONDITION TO YOUR USE OF THE SERVICE, YOU AGREE TO BE BOUND BY, THESE RAFFLE TERMS. IF YOU ARE NOT ELIGIBLE, OR DO NOT AGREE TO THESE RAFFLE TERMS, THEN YOU DO NOT HAVE OUR PERMISSION TO PARTICIPATE IN THE RAFFLE. YOUR PARTICIPATION IN THE RAFFLE CONSTITUTES AN AGREEMENT BY LAGRANGE AND BY YOU TO BE BOUND BY THESE RAFFLE TERMS.


BY PARTICIPATING IN THE RAFFLE, YOU EXPRESSLY ACKNOWLEDGE AND ASSUME ALL RISKS RELATED THERETO, INCLUDING (WITHOUT LIMITATION) THE RISKS SET OUT BELOW. IN NO EVENT SHALL LAGRANGE BE HELD LIABLE IN CONNECTION WITH OR FOR ANY CLAIMS, LOSSES, DAMAGES, OR OTHER LIABILITIES, WHETHER IN CONTRACT, TORT, OR OTHERWISE, ARISING OUT OF OR IN CONNECTION WITH THE RAFFLE OR THE RECEIPT OF ANY PRIZES.

#### 1. RAFFLE

- 1.1. These Terms describe your participation in Lagrange's Raffle. The Raffle shall be conducted between July 22, 2025 to August 1, 2025, as determined by Lagrange in its sole discretion. The Prizes won by participants will be determined by Lagrange, in its sole discretion.

#### 2. Eligibility

- 2.1. To be eligible to enter the raffle, you must

- Be a member of the official Lagrange Discord server
- Hold at least 10 \$LA tokens in a verifiable wallet
- Complete onboarding steps as outlined in the #  | deep\_dive-start\_here channel
- Enter the #la-goldfish channel and click "Participate" to confirm entry

- 2.2. Lagrange will determine whether you are permitted to participate in the Raffle in Lagrange's sole discretion. You must be at least 18 years old to participate in the Raffle. By agreeing to these Terms, you represent and warrant to us that: (a) you are at least 18 years old; (b) you are eligible to receive and own a Prize; and (c) your registration for and participation in the Raffle is in compliance with any and all applicable laws and regulations, including any country or territory-specific laws and regulations. If you are an entity, organization, or company, the individual accepting these Terms on your behalf represents and warrants that they have authority to bind you to these Terms and you agree to be bound by these Terms. You agree that you will not use a virtual private network or similar tool to circumvent any geo-blocking

and/or other restrictions that we have implemented in connection with the Raffle. Any such deliberate circumvention, or attempted circumvention, of our controls may permanently disqualify you from participation in the Raffle, as determined in our discretion.

- 2.3. You agree and acknowledge that your participation in the Raffle does not violate any applicable laws, including without limitation applicable economic and trade sanctions and export control laws and regulations, such as those administered and enforced by the EU, OFSI, OFAC, the U.S. Department of State, the U.S. Department of Commerce, the UN Security Council, and other relevant authorities.

### **3. Prizes**

- 3.1. The following prizes will be awarded through a randomized raffle among eligible Goldfish participants:

- (a) 1st Prize: Roundtrip to TOKEN2049 Singapore (Oct 1–2) + Event Ticket + Personalized Medallion
- (b) 2nd Prize: Custom PlayStation 5 + Medallion
- (c) 3rd–5th Prizes: Lagrange Bomber Jacket + Medallion
- (d) 6th–10th Prizes: Exclusive Collectible Medallion

- 3.2. Each Medallion grants access to all official Lagrange Foundation events held during the Deep Dive campaign period.

- 3.3. Prizes are non-transferable. The Lagrange Foundation reserves the right to replace any prize with one of equal or greater value in the case of availability issues or other constraints.

### **4. Winner Selection and Notification**

- 4.1. Winners will be randomly selected after the campaign ends.
- 4.2. They will be contacted via Discord and must respond within 7 calendar days.
- 4.3. Unresponsive winners may be disqualified and replaced by alternate participants.

### **5. General Conditions**

- 5.1. The Lagrange Foundation reserves the right to alter, suspend, or cancel the raffle if necessary due to system compromise, fraud, or technical issues.
- 5.2. Any participant found cheating, attempting to manipulate results, or violating campaign rules will be removed.
- 5.3. Where physical delivery of prizes is not possible (due to tariffs, customs restrictions, or regional limitations), Lagrange may offer equivalent value in USDT at its discretion.

### **6. Registration, Digital Wallet, and Access**

- 6.1. In order to participate in the Raffle, you will need to link a supported electronic wallet (a "Wallet") and may need to provide other information about yourself, such as your social media account and other information requested by Lagrange from time to time. Wallet verification is handled by Collab.Land, a third-party tool integrated with our Discord server. By connecting your wallet, you agree to Collab.Land's Terms of Service and privacy practices. Lagrange does not assume any responsibility for or liability with respect to any Wallet. By connecting a third-party Wallet, you agree to abide by the terms and conditions of the applicable Wallet provider. You must familiarize yourself with the terms of use, technology, and security protocols of any Wallet. You are solely responsible for maintaining the security of your Wallet, including your credentials, private key, and/or seed phrase. We are in no way liable for any acts or omissions by you in connection with your Wallet or losses or liabilities as a result of your Wallet being compromised. You should make contingency plans with respect to your Wallet in the event of your death or incapacity; otherwise, you (and your executor, guardian, or heirs) may lose access to your Wallet and your cryptocurrency.
- 6.2. You represent and covenant to Lagrange that any Wallet used by you in connection with the Raffle is and will be controlled exclusively and directly by you and no other person. You represent and warrant that all information provided during the Raffle process is true, accurate, and complete.
- 6.3. You agree that Lagrange may share any information you provide in connection with the Raffle in its sole discretion, including to reduce the risks of money laundering, terrorist financing, sanctions violations, or other potentially illicit activity, or as otherwise necessary to address laws and regulations that may be relevant to the Raffle or the Prizes.
- 6.4. You agree and acknowledge that if you are unable to participate in the Raffle or claim the Prizes due to technical bugs, smart contract issues, gas fees, wallet incompatibilities, loss of access to a wallet or the key thereto, or for any other reason, you will have no recourse or claim against us or our affiliates. Without limitation to the generality of any provision in these Terms and Conditions, in any such cases, neither we nor our affiliates will bear any liability.
- 6.5. You agree and acknowledge that participating in the Raffle and claiming the Prizes may require interaction with, reliance on, or an integration with third-party products or services (e.g., a wallet or a network or blockchain) that we do not control. In the event that you are unable to access such products, services, or integrations, or if they fail for any reason, and you are unable to participate in the Raffle or claim Prizes as a result, you will have no recourse or claim against us or any of our affiliates; and neither we nor any of our affiliates bear(s) any responsibility or liability to you.
7. **Payment and Fees**
- 7.1. You agree and acknowledge that your participation in the Raffle and claim of Prizes does not require or involve any form of purchase, payment, or tangible consideration from or to us, nor otherwise require or involve any acceptance of value by us from you. You agree and acknowledge that you (a) are eligible to (as set forth in Section 2) and lawfully may receive Prizes for free via the Raffle (other than custom duties or applicable taxes, if any, that may be due to third parties), (b) were not promised the Prizes or any Prizes (whether via the Raffle or otherwise); and (c) took no action in anticipation of, or in reliance on, receiving the Prizes or any Prizes, the occurrence of an Raffle, or potential participation in any Raffle.

- 7.2. You agree and acknowledge that (a) you are solely responsible and liable for all taxes, fees, duties and governmental assessments (except for taxes based on Lagrange's net income) due in connection with your participation in the Raffle; and (b) you should consult a tax advisor with respect to the tax treatment of Prizes in your jurisdiction.
8. Indemnity. You agree to defend, indemnify, and hold Lagrange, its affiliates and their respective shareholders, directors, managers, members, officers, employees, consultants, and agents (the "Lagrange Entities") harmless from and against any and all claims, actions, proceedings, investigations, demands, suits, costs, damages, losses, liabilities and expenses (including attorneys' fees and costs, and fines or penalties (including any disgorgement) imposed by any regulatory authority) incurred by the Lagrange Entities arising out of or in connection with: (a) your participation in, or conduct in connection with, the Raffle, including your linking your Wallet to participate in the Raffle, or your receipt or use of any Prizes; (b) your breach or our enforcement of these Terms, or (c) your violation of any applicable law, regulation, or rights of any third party. We reserve the right, at our own expense, to assume the exclusive defense and control of any matter otherwise subject to indemnification by you (without limiting your indemnification obligations with respect to that matter), and in that case, you agree to cooperate with our defense of those claims. Your obligations under this indemnification provision will continue even after these Raffle Terms have expired or been terminated.
9. Warranty Disclaimer
- 9.1. PARTICIPATION IN THE RAFFLE IS AT THE YOUR OWN RISK. THE RAFFLE AND ALL PRIZES PROVIDED ON AN "AS IS" AND "AS AVAILABLE" BASIS. LAGRANGE EXPRESSLY DISCLAIMS ALL WARRANTIES OF ANY KIND, WHETHER EXPRESS, IMPLIED, OR STATUTORY, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE, AND NON-INFRINGEMENT.
- 9.2. LAGRANGE MAKES NO WARRANTY THAT THE RAFFLE OR THE PRIZES WILL MEET YOUR REQUIREMENTS OR BE UNINTERRUPTED, TIMELY, SECURE, OR ERROR-FREE. LAGRANGE MAKES NO WARRANTY THAT THE RESULTS THAT MAY BE OBTAINED FROM ACCESS TO OR THE PARTICIPATION IN THE RAFFLE WILL BE ACCURATE OR RELIABLE OR THAT THE QUALITY OF ANY PRODUCTS, SERVICES, APPLICATIONS, INFORMATION, OR OTHER MATERIAL OBTAINED BY YOU THROUGH THE RAFFLE WILL MEET YOUR EXPECTATIONS.
- 9.3. THE LIMITATIONS, EXCLUSIONS AND DISCLAIMERS IN THIS SECTION 9 (WARRANTY DISCLAIMER) APPLY TO THE FULLEST EXTENT PERMITTED BY LAW. Lagrange does not disclaim any warranty or other right that Lagrange is prohibited from disclaiming under applicable law.
10. No Professional Advice and No Fiduciary Duties
- 10.1. All information provided on the website, Discord, or through the Raffle, or otherwise provided by Lagrange, is for informational and entertainment purposes only and is not and should not be construed as professional advice. You should not take, or refrain from taking, any action based on any information contained on the website or obtained through the Raffle. Before you make any financial, legal, tax, or other decisions with respect to the Raffle or the Prizes, you should seek independent, professional advice from an individual who is licensed and qualified in the area for which such advice would be appropriate.

- 10.2.** These Raffle Terms are not intended to, and do not, create or impose any fiduciary duties on us. To the fullest extent permitted by law, you acknowledge and agree that we owe no fiduciary duties or liabilities to you or any other party, and that to the extent any such duties or liabilities may exist at law or in equity, those duties and liabilities are hereby irrevocably disclaimed, waived, and eliminated. You further agree that the only duties and obligations that we owe you are those set out expressly in these Raffle Terms.
- 11.** Your Warranties. By participating in the Raffle, you represent and warrant that you (a) will comply with all applicable laws in your participation in the Raffle and your possession and use of the Prizes, (b) understand the risks inherently associated with using cryptographic and blockchain-based systems, (c) have a working knowledge of the usage, storage, and intricacies of digital assets, and (d) you understand that markets for digital assets are highly volatile due to various factors, including adoption, speculation, technology, security, and regulation. You acknowledge and accept that the cost and speed of transacting with cryptographic and blockchain-based systems are variable and may increase or decrease dramatically at any time. You acknowledge and accept the risk that your digital assets may have no value or lose some or all of their value at any time. You understand that anyone can create a token, including fake versions of the Tokens, or other existing tokens and tokens that falsely claim to represent certain projects, entities, or people, and you acknowledge and accept the risk that you or others may mistakenly seek to claim or trade those or other tokens. You acknowledge that Lagrange is not responsible for any of these variables or risks and cannot be held liable for any resulting losses that you experience, including losses while participating in the Raffle. Accordingly, you understand and agree to assume full responsibility for all of the risks of participating in the Raffle.
- 12.** Limitation of Liability
- 12.1.** TO THE FULLEST EXTENT PERMITTED BY LAW, IN NO EVENT WILL THE LAGRANGE ENTITIES BE LIABLE TO YOU FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL OR PUNITIVE DAMAGES (INCLUDING DAMAGES FOR LOSS OF PROFITS, GOODWILL, OR ANY OTHER INTANGIBLE LOSS) ARISING OUT OF OR RELATING TO YOUR PARTICIPATION IN, OR YOUR INABILITY TO PARTICIPATE IN, THE RAFFLE, WHETHER BASED ON WARRANTY, CONTRACT, TORT (INCLUDING NEGLIGENCE), STATUTE, OR ANY OTHER LEGAL THEORY, AND WHETHER OR NOT ANY LAGRANGE ENTITY HAS BEEN INFORMED OF THE POSSIBILITY OF DAMAGE.
- 12.2.** EXCEPT AS PROVIDED IN THE GENERAL TERMS AND TO THE FULLEST EXTENT PERMITTED BY LAW, THE AGGREGATE LIABILITY OF THE LAGRANGE ENTITIES TO YOU FOR ALL CLAIMS ARISING OUT OF OR RELATING TO YOUR PARTICIPATION IN OR ANY INABILITY TO PARTICIPATE IN ANY PORTION OF THE RAFFLE OR OTHERWISE UNDER THESE TERMS, WHETHER IN CONTRACT, TORT, OR OTHERWISE, IS LIMITED TO THE AMOUNT YOU HAVE PAID TO LAGRANGE FOR PARTICIPATION IN THE RAFFLE.
- 12.3.** EACH PROVISION OF THESE TERMS THAT PROVIDES FOR A LIMITATION OF LIABILITY, DISCLAIMER OF WARRANTIES, OR EXCLUSION OF DAMAGES IS INTENDED TO AND DOES ALLOCATE THE RISKS BETWEEN THE PARTIES UNDER THESE TERMS. THIS ALLOCATION IS AN ESSENTIAL ELEMENT OF THE BASIS OF THE BARGAIN BETWEEN THE PARTIES. EACH OF THESE PROVISIONS IS SEVERABLE AND INDEPENDENT OF ALL OTHER PROVISIONS OF THESE TERMS. THE LIMITATIONS IN THIS SECTION 9 (LIMITATION OF LIABILITY) WILL APPLY EVEN IF ANY LIMITED REMEDY FAILS OF ITS ESSENTIAL PURPOSE.

- 12.4.** You have reviewed with your professional legal and other advisors and agree with the Warranty Disclaimers, indemnification provisions and Limitations of Liability in these Terms and Conditions.
- 13.** **Miscellaneous.** These Raffle Terms, including the General Terms and any other agreements expressly incorporated by referenced into these Terms, are the entire and exclusive understanding and agreement between you and Lagrange regarding your participation in the Raffle. You may not assign or transfer these Terms or your rights under these Terms, in whole or in part, by operation of law or otherwise, without our prior written consent. We may assign these Terms and all rights granted under these Terms at any time without notice or consent. The failure to require performance of any provision will not affect our right to require performance at any other time after that, nor will a waiver by us of any breach or default of these Terms, or any provision of these Terms, be a waiver of any subsequent breach or default or a waiver of the provision itself. Use of Section headers in these Terms is for convenience only and will not have any impact on the interpretation of any provision. Throughout these Terms the use of the word “including” means “including but not limited to.” If any part of these Terms is held to be invalid or unenforceable, then the unenforceable part will be given effect to the greatest extent possible, and the remaining parts will remain in full force and effect.
