OFFICIAL CONTEST RULES & REGULATIONS

"Unwrap the Season – Holiday Hunt"

The "**Unwrap the Season – Holiday Hunt**" (the "**Contest**") is sponsored by North Central Co-operative Association Ltd. (the "**Sponsor**"). The Contest begins 8:00 am MST December 4th, 2025 (the "**Contest Start Date**") and ends 11:59 pm MST December 31st, 2025 (the "**Contest Closing Date**"), known as the "**Contest Period**".

1. HOW TO ENTER:

NO PURCHASE NECESSARY. A purchase will not increase your chance of winning.

- Valid codes are randomly displayed at participating North Central Co-op Food Store locations on clearly market in-store promotional materials.
- Visit coopandyou.ca, the Official Contest Page, and enter one (1) valid code, your valid member number and email address to earn one (1) entry into the Contest.
- Each valid code can only be entered once.
- Enter additional valid codes until the Contest Closing Date to earn additional entries into the Contest.

2. ELIGIBILITY:

Eligible

To enter the Contest and be eligible to win a prize in the Contest, a person must hold a valid membership with North Central Co-operative Association Ltd., be a resident of or live in proximity to Edmonton and be the age of majority in the jurisdiction in which he or she resides as of the Contest Start Date.

Not Eligible

Residents outside of or not in proximity to Edmonton and do not hold a valid North Central Co-operative Association Ltd. membership are not eligible to enter the Contest.

The Sponsor's employees and the Sponsor's Board of Director as well as the immediate family* and those domiciled with the Sponsor's employees and Board of Directors are not eligible to participate in the Contest or win prizes in the Contest.

Employees of Participating Stores, the Participating Stores' Boards of Directors as well as the immediate family* and those domiciled with the Participating Stores' employees and the Participating Stores' Board of Directors are not eligible to participate in the Contest or win prizes in the Contest.

Employees of the Sponsor's and the Participating Stores' operators, affiliates, agents, independent judging organization, consulting, advertising and promotional agencies, as well as those domiciled with and the immediate family* of the foregoing, are not eligible to participate in the Contest or win prizes in the Contest.

Has won an affiliate contest promoted by the Sponsor in the past twelve (12) months.

* "Immediate family" means members living in the same household.

4. PRIZE WINNER:

The winner will be randomly selected on or about January 2nd, 2026, from all valid entries. The selected entrant will be contacted within seven days of the decision date. If a selected entrant cannot be contacted within seven days of the draw date his/her entry will be disqualified and another entrant will be selected. To be declared a prize winner (the "Prize Winner"), the selected entrant must: (1) correctly answer a mathematical skill testing question to be administered via telephone, mail or email; (2) show government identification to confirm identity; and (3) complete, sign and return a Statement of Compliance, Release and Indemnity Agreement to the Sponsor within seven days of receipt of written prize notification or prize will be forfeited and an alternate Prize Winner selected. Prize Winners consent to the use of their name, address (city and province) and photograph without compensation, in any future publicity carried out by the Sponsor or the Participating Stores.
