OFFICIAL CONTEST RULES & REGULATIONS

"Fuel Good Day 10th Anniversary"

The "**Fuel Good Day 10th Anniversary**" (the "**Contest**") is sponsored by North Central Co-operative Association (the "**Sponsor**"). The Contest begins 6:00 am MST September 15th, 2026 (the "**Contest Start Date**") and ends 10:00 pm MST September 15th, 2026 (the "**Contest Closing Date**"), known as the "**Contest Period**".

1. HOW TO ENTER:

NO PURCHASE NECESSARY. A purchase will not increase your chance of winning.

- Generate an in-store entry code at coopandyou.ca/fuelgoodday.
- Visit a participating North Central Co-op Gas Bar **on September 15th ONLY** and bring the code inside.
- Scan the Fuel Good Day "Enter to Win" **in-store** display sign.
- Submit your valid entry code to be entered into a chance to win the "Prize".
- Max one entry per customer on Fuel Good Day, September 15th, 2026.

2. ELIGIBILITY:

Eligible

To enter the Contest and be eligible to win a prize in the Contest, a person must be a resident of or live in proximity to Edmonton and be the age of majority in the jurisdiction in which he or she resides as of the Contest Start Date.

Not Eligible

Residents outside of or not in proximity to Edmonton are not eligible to enter the Contest.

The Sponsor's employees and the Sponsor's Board of Director as well as the immediate family* and those domiciled with the Sponsor's employees and Board of Directors are not eligible to participate in the Contest or win prizes in the Contest.

Employees of Participating Stores, the Participating Stores' Boards of Directors as well as the immediate family* and those domiciled with the Participating Stores' employees and the Participating Stores' Board of Directors are not eligible to participate in the Contest or win prizes in the Contest.

Employees of the Sponsor's and the Participating Stores' operators, affiliates, agents, independent judging organization, consulting, advertising and promotional agencies, as well as those domiciled with and the immediate family* of the foregoing, are not eligible to participate in the Contest or win prizes in the Contest.

Has won an affiliate contest promoted by the Sponsor in the past twelve (12) months.

* "Immediate family" means members living in the same household.

3. PRIZE: 1 of 8 \$500 Co-op Gift Cards. Retail Value: \$500.00 each

Prizes must be accepted as awarded. Prizes may not be sold, converted to cash, are non-transferable, and no substitutions are permitted. One prize per winning entry; one prize per household. The Sponsor reserves the right, in the event that a prize or any component of a prize cannot be awarded as described for any reason, to substitute another prize of equal or greater value without liability. The odds of being selected are dependent upon the total number of eligible entries received during the Contest Period.

4. PRIZE WINNER:

The winner will be randomly selected on or about September 16th, 2026, from all valid entries. The selected entrant will be contacted within seven days of the decision date. If a selected entrant cannot be contacted within seven days of the draw date his/her entry will be disqualified and another entrant will be selected. To be declared a prize winner (the "Prize Winner"), the selected entrant must: (1) correctly answer a mathematical skill testing question to be administered via telephone, mail or email; (2) show government identification to confirm identity; and (3) complete, sign and return a

Statement of Compliance, Release and Indemnity Agreement to the Sponsor within seven days of receipt of written prize notification or prize will be forfeited and an alternate Prize Winner selected. Prize Winners consent to the use of their name, address (city and province) and photograph without compensation, in any future publicity carried out by the Sponsor or the Participating Stores.
