2. FEIF Original Certificate of Registration OR Certificate of Ownership. Original certificates will be returned with the USIHC certificate of Registration. Do **not** send the passport
3. USIHC DNA application or DNA report from UC Davis (geldings excluded). Do **not** send hair.
4. Verification of Import Date if imported from anywhere but Iceland.
5. A check for the correct amount made payable to the USIHC registry. Proof of payment for the registration fees if paid online.
