

SKILLCORNER SCCS ADDENDUM

1. **GENERAL**

- 1.1 All capitalised terms below shall have the meaning given to them in the Agreement, where the context permits. In the event of any conflict or contradiction between this SCCs Addendum and the Agreement, the terms of this SCCs Addendum shall prevail.
- 1.2 Part 1 (EU SCCs) of the SCCs Addendum applies between the Parties, and the Parties agree to the terms of Part 1 (EU SCCs) of the SCCs Addendum, where:
 - 1.2.1 SkillCorner is subject to the EU GDPR for the given processing of Player Personal Data that is being transferred, and SkillCorner is agreeing to send Player Personal Data, or make it accessible, to the Partner which is located in a country or territory outside the European Economic Area; and
 - 1.2.2 the Partner is not located in a third country or territory that is covered by an adequacy decision made by the European Commission.
- 1.3 Part 2 (UK SCCs) of the SCCs Addendum applies between the Parties, and the Parties agree to the terms of Part 2 (UK SCCs) of the SCCs Addendum, where:
 - 1.3.1 SkillCorner is subject to the UK GDPR for the given processing of Player Personal Data that is being transferred, and SkillCorner is agreeing to send Player Personal Data, or make it accessible, to the Partner which is located in a country or territory outside the UK; and
 - 1.3.2 the Partner is not located in a third country or territory that is covered by an adequacy decision made by the Information Commissioner's Office.
- 1.4 If any Authorised Third Parties or Additional Users are accessing the Services on the Partner's behalf, the Partner shall ensure that it enters into any data protection terms with such Authorised Third Parties or Additional Users (to the extent that such terms are required under Data Protection Laws).

2. EU SCCS

- The Parties hereby agree to the terms in the Annex to the Commission Implementing Decision (EU) 2021/914 of 4 June 2021 on standard contractual clauses for the transfer of Personal Data to third countries pursuant to Regulation (EU) 2016/679 of the European Parliament and of the Council (Text with EEA relevance), C/2021/3972 ("EU SCCs"), incorporating the terms of Module One (controller to controller) of the EU SCCs, accessible here: https://eur-lex.europa.eu/eli/dec_impl/2021/914/oj).
- 2.2 The details of the data transfer are set out below and shall be deemed incorporated as Annex I of the EU SCCs, and the details of the technical and organisational measures shall be deemed incorporated as Annex II of the EU SCCs.
