In accordance with the requirements of the Public Offering of Securities Act, Ordinance 2 of the FSC and Article 17 of Regulation 596/2014 of the EP and the Council, we inform you of the following: On 23.12.2022, at a meeting of the Board of Directors of Sirma Group Holding JSC, the decision of the Board of Directors of the subsidiary company Sirma Solutions JSC to dispose of the entire minority package of shares in the subsidiary company Sirma AI JSC was approved as follows:

- Subsidiary company owner of the minority share package: Sirma Solutions JSC;
- Size of the minority package subject to disposal: 23.80% of the capital of Sirma AI JSC;
- Subsidiary whose shares are subject to disposal: Sirma AI JSC;
- Transaction value: EUR 9,460,000;
- Potential buyers of shares: Further development of the proposed transaction is subject to approval by the financing banks and the General Meeting of Shareholders of Sirma Group Holding JSC.
