



Winter promotion 2026 — \$100k giveaway

TERMS & CONDITIONS — JUNE 2026



Promoter: Faisandier Group Limited (company number 7185034),
Level 2, 3 Margaret Street, Hutt Central, Wellington, New Zealand
("Faisandier").

1. Promotion period

The Promotion opens at 9:00am NZST on 1 June 2026 and closes at 5:00pm NZST on 15 July 2026 (the "Promotion Period"). Faisandier may, in its sole discretion, extend the Promotion Period to 5:00pm NZST on 31 July 2026 by notice published on [faisandier.homes](https://www.faisandier.homes).

2. Eligible stock

The Promotion applies to residential units offered for sale by Faisandier at the following projects only (the "Eligible Projects"):

- 8 Rongonui Street
- 123 Knights Road
- 53 Brook Street
- 75 Pretoria Street
- 3 Raukawa Street
- 1 Nikau Grove

Only completed and off-the-plan units within the Eligible Projects that are available for sale as at the start of the Promotion Period constitute "Eligible Stock". A list of Eligible Stock as at the start of the Promotion Period will be maintained by Faisandier and made available on request.



3. Eligibility

The Promotion is open to the first five (5) buyers who, during the Promotion Period:

- (a) enter into a Sale and Purchase Agreement ("SPA") with Faisandier for a unit comprising Eligible Stock;
- (b) at the full advertised asking price for that unit at the time of execution; and
- (c) whose SPA subsequently becomes unconditional and proceeds to settlement.

Buyers must be aged 18 or over and must be eligible to purchase residential land in New Zealand under the Overseas Investment Act 2005.

4. The offer

Each eligible buyer will receive a NZ\$20,000 (incl. GST) furniture credit (the "Credit"), redeemable at a Faisandier-approved furniture retailer such as Freedom Furniture, Harvey Norman or Cittá. The specific retailer applicable to each Credit will be confirmed by Faisandier prior to settlement and will be a retailer with which Faisandier has arranged Credit redemption.

Total prize pool: NZ\$100,000 (5 Credits × NZ\$20,000 incl. GST).

5. Exclusions

The following are not eligible for the Promotion:

- (a) units that are already under contract, conditional offer, or previously sold at the start of the Promotion Period;



(b) any SPA at a price below the full advertised asking price (including any SPA where a reduction, rebate, contribution, or other concession is given that has the effect of reducing the net price below the asking price);

(c) any SPA that does not become unconditional, or that is cancelled, rescinded, or otherwise terminated prior to settlement;

(d) any SPA for a completed unit where settlement does not occur within four (4) weeks of the date the SPA becomes unconditional. For the avoidance of doubt, this sub-clause does not apply to off-the-plan units where the property is not yet completed at the time the SPA becomes unconditional – in those cases, settlement must occur in accordance with the SPA terms upon completion.

6. Credit trigger and delivery

The Credit will be issued on the settlement date of the eligible buyer's SPA. Faisandier will arrange for the retailer to coordinate with the buyer for purchasing the furniture, with payment being made via invoice directly to Faisandier Group Limited.

7. Credit mechanics

(a) Expiry. The Credit must be redeemed in full within three (3) months of the date of issue. Any unused balance expires at that point and has no cash value.

(b) Single retailer. Credit is redeemable at one (1) Faisandier-approved retailer only and cannot be split across multiple retailers.

(c) Non-transferable, non-cashable. The Credit is issued in the name(s) of the buyer(s) on the SPA and is not transferable to a



third party. The Credit cannot be redeemed for cash, exchanged for other goods or services outside the issuing retailer, or used in conjunction with another promotion unless the retailer expressly permits.

(d) Retailer terms apply. Redemption is subject to the issuing retailer's standard terms, stock availability, store trading hours, and any delivery charges (which are not covered by the Credit unless agreed by the retailer).

(e) Tax. Any tax consequences arising from receipt or use of the Credit are the responsibility of the recipient. Faisandier makes no representation as to the tax treatment of the Credit.

(f) Not combinable. The Credit and the Promotion cannot be combined with any other promotion, discount, rebate, contribution, or incentive offered by Faisandier.

8. Multiple eligible contracts — order of priority and tie-breaker

Where more than five (5) eligible SPAs are signed during the Promotion Period, the first five SPAs in chronological order (by the date and time of signing by the buyer(s)) will be the eligible recipients of the Credits.

Where two or more eligible SPAs are signed on the same day, priority will be determined by the time at which the fully buyer-signed SPA is received by Faisandier's sales agent or solicitor (whichever is earlier). If the time of receipt cannot reasonably be determined, Faisandier will determine the order of priority in its sole discretion, acting reasonably.



9. Faisandier's rights

Faisandier reserves the right, at any time and in its sole discretion, to:

- (a) vary, suspend, or withdraw the Promotion (in whole or in part);
- (b) vary these Terms;
- (c) substitute an approved retailer where the nominated retailer becomes unable or unwilling to honour the Credit, in which case Faisandier will substitute a retailer of equivalent standing;
- (d) disqualify any buyer who, in Faisandier's reasonable opinion, has engaged in fraudulent, misleading, or unfair conduct in connection with the Promotion.

Any variation, suspension, or withdrawal of the Promotion will not affect Credits already issued to buyers whose SPAs have settled.

10. Liability

To the maximum extent permitted by law, Faisandier is not liable for any loss, damage, cost, or claim arising out of or in connection with the Promotion, the issue or non-issue of a Credit, or the use, non-use, or non-acceptance of a Credit by any retailer. Nothing in these Terms limits the buyer's rights under the Consumer Guarantees Act 1993 or the Fair Trading Act 1986 where those Acts apply.

11. Third-party platforms

The Promotion is not in any way sponsored, endorsed, or administered by, or associated with, any social media platform or third-party website used to promote, advertise, or otherwise



facilitate the Promotion, including without limitation Meta (Facebook and Instagram).

12. Privacy

Personal information collected in connection with the Promotion will be handled in accordance with the Privacy Act 2020 and Faisandier's Privacy Policy, available at faisandier.homes/privacy. By entering the Promotion, each buyer consents to Faisandier using their personal information to conduct the Promotion and to keep them informed about Faisandier's projects and operations, and to Faisandier disclosing their contact details to its sales agent, solicitor, and the issuing retailer to the extent necessary to arrange and deliver a Credit.

13. Governing law

These Terms are governed by the laws of New Zealand and the parties submit to the non-exclusive jurisdiction of the New Zealand courts. The Promoter's decision on all matters relating to the Promotion is final and no correspondence will be entered into.
