## Submitting a DMCA Notice

Pursuant to the **Digital Millennium Copyright Act (DMCA)**, 17 U.S.C. § 512, your notification must include the following details:

1. **Your physical or electronic signature.**
  2. **A clear identification of the copyrighted work** (or a list of works, if multiple).
  3. **A detailed description of the infringing content**, including its specific location on our Website.
  4. **Your contact information**, including full name, mailing address, telephone number, and email address (if available).
  5. **A good faith statement** that you believe the disputed use is not authorized by the copyright or trademark owner, their agent, or the law.
  6. **A declaration of accuracy** of the information provided.
  7. **A sworn statement** under penalty of perjury that you are authorized to act on behalf of the intellectual property owner.

## Where to Send Your DMCA Notice

You may submit your DMCA Notice to **GR Select's** designated copyright agent using the contact form on our website or by email listed on our website's Contact page.

**Please Note:**

Failure to include all required information under **Section 512(c)(3)** of the DMCA may result in your notice being deemed ineffective.
