Introduction

At **GR Select LLC** ("GR Select", "we", "us", or "our"), we are committed to protecting your privacy and ensuring that your personal data is handled responsibly and transparently. This policy outlines how we collect, use, and protect your information when you use our website **grselect.com** ("Website"), and explains your legal rights in relation to that data.

This Privacy Policy applies to users located in the United States and, where applicable, to individuals in the EU or UK in accordance with the General Data Protection Regulation (GDPR).

1. Who We Are

2. What Data We Collect

We may collect and process the following types of personal data:

- **Identity Data** (e.g., name, gender, date of birth)

- **Financial Data** (e.g., credit card or payment information)
- **Transaction Data** (e.g., service or product history)
- **Technical Data** (e.g., IP address, browser type, device info)

- **Usage Data** (e.g., browsing history, interaction with our content)
- **Marketing and Communications Data** (e.g., opt-in preferences)

We also collect **Aggregated Data** for analytics and performance improvement, which does not personally identify you.

We do **not** collect any Special Categories of Personal Data (e.g., health, religious beliefs, race, political affiliation).

3. How We Collect Your Data

We collect data in the following ways:

- **Direct interactions:** When you complete forms, make purchases, or contact us.
- **Automated technologies:** Through cookies and analytics tools when you browse our site.
- **Third-party sources:** Such as payment providers, analytics platforms (e.g., Google Analytics), and marketing services.

4. How We Use Your Data

We use your data to:

- Process orders and provide services.

We do not sell or rent your personal information.

We take appropriate technical and organizational measures to secure your data, including encryption, access controls, and breach response procedures. Only authorized personnel can access your information.

8. Data Retention

We retain your personal data only as long as necessary to fulfill the purposes we collected it for, including legal, accounting, or reporting requirements. You may request deletion of your data as outlined below.
