DECLARATION

European and UK Resident Declaration

Information on the Provision of Brokerage Services by Born2Trade Ltd to EU/EEA and UK Residents

Born2Trade Ltd (acting under the Born2trade brand) is incorporated under the company number: 2025-00375 in Saint Lucia.

In accordance with MiFID II (Directive 2014/65/EU), residents of the European Union and the United Kingdom may receive investment services from a third country (non-EU/UK) firm only at their own exclusive initiative.

Furthermore, under Article 46 of UK MiFIR, the Financial Services and Markets Act 2000 (Regulated Activities) Order 2001, Article 72, and the FCA Perimeter Guidance Manual (PERG) Sections 8.37.11(1) and 8.37.11(2), UK residents may also receive investment services from a third-country firm solely at their own exclusive initiative and at their own expense.

If you wish to proceed with opening an account and signing this declaration, please ensure that you have carefully reviewed and understood the limitations and risks associated with trading through a third-country firm.

Important Notice: Limitations of Engaging with a Third-Country Firm

When choosing to receive investment services from a third country (non-EU/UK) firm, please be aware of the following limitations:

- You are not covered by the EU or UK Investor Compensation Fund (ICF).
- You cannot file complaints or raise claims with your local EU/UK authorities. Any concerns must first be addressed directly with the Company, and if necessary, escalated to the Company's regulator.
- You are not protected under EU, EEA, or UK regulatory frameworks, and therefore cannot appeal to EU/EEA/UK regulators in the event of a dispute with the Company.

Prior to opening an account, you must declare the following:

- I declare that the provision of investment services and/or the performance of investment activities by the Company was initiated solely at my own exclusive initiative.
- I understand that my activities with the Company fall outside the scope of the European legal framework and protections, and I accept the risks associated with this.

- I agree to receive the Terms of Business and all regulatory disclosures exclusively in the English language.
- In the event of a dispute with the Company, I agree to follow the dispute resolution procedure outlined in the Client Agreement.

Governing Law and Jurisdiction

The relationship between Born2Trade Ltd (the Company) and me (the Client) shall be governed by and construed in accordance with the laws of Saint Lucia, which shall serve as the sole and exclusive governing law.

As the Client, I further acknowledge and agree that:

- The courts of Saint Lucia shall have exclusive jurisdiction over all disputes arising out of or in connection with the relationship between the Company and myself, including but not limited to any orders, transactions, instructions, or the Client Agreement.
- I shall not claim any inconvenience arising from the jurisdiction or location of the Saint Lucia courts, nor shall I dispute their authority or jurisdiction over me as the Client.
- I hereby waive any right of appeal against decisions rendered by the courts of Saint Lucia.
