Eligible Account: Dynamic Account only

Instruments: Gold (XAU/USD) and Silver (XAG/USD) CFDs

Last updated: 25 August 2026

1. Promotion

Eligible long positions in XAU/USD and XAG/USD on Dynamic Accounts may receive positive overnight swaps in accordance with the applicable trading specifications.

The Promotion is intended for genuine trading activity involving real market exposure and must not be used for hedging, arbitrage, artificial volume generation, or any other activity designed primarily to obtain a risk-free or materially reduced-risk swap benefit.

The promotion is valid until 31/12/2026. The company reserves the right to end the promotion prior to this date, informing the clients in writing 5 days before the end of the promotion.

2. Prohibited Conduct

Clients must not:

- hedge or substantially offset XAU/USD or XAG/USD positions between different Born2Trade account types;
- hedge such positions through another company within the Born2Trade group;
- use another account owned, controlled or coordinated by the Client or a related person to offset promotional positions;
- engage in swap arbitrage, internal or external hedging, multi-accounting, coordinated trading, latency or price arbitrage;
- use automated systems, Expert Advisors or copy-trading arrangements

primarily to exploit differences in swap conditions;

- exploit pricing, swap, rollover, execution or platform errors; or
- engage in any fraudulent, abusive or bad-faith activity intended to obtain an improper promotional benefit.

For the purpose of these Terms, prohibited hedging includes opposite or substantially offsetting positions where one account receives positive swaps while another account, account type or Born2trade group company applies different, neutral or negative swap conditions.

3. Connected Accounts

The Company may treat accounts as connected where there are reasonable grounds to believe that they are owned, controlled or coordinated by the same or related persons.

The Company may consider factors including beneficial ownership, shared contact details, devices, IP addresses, payment methods, trading patterns, timing and size of offsetting positions, automated trading connections and other relevant account information.

4. Company Rights in Case of Abuse

Where the Company reasonably determines that these Terms have been breached, it may, subject to the Client Agreement and applicable law:

- remove the Client from the Promotion;
- discontinue positive swap treatment;
- cancel, adjust or reverse promotional swap credits obtained through prohibited activity;
- restrict or close affected positions where permitted;
- apply standard swap conditions;
- suspend or terminate affected accounts or the Client relationship; and
- reverse related affiliate or partner remuneration.

Any adjustment should, where reasonably practicable, relate to the benefit obtained through the prohibited activity.
