The Western Business Law Clinic (WBLC) provides small and emerging businesses in London and the Greater Toronto Area with the legal support they need to get started and grow. Whether it's incorporations, partnership or shareholder agreements, or business documents like investor, contractor and confidentiality agreements, the clinic helps entrepreneurs tackle the essentials with confidence. Every file is reviewed by mentor lawyers, ensuring clients receive trusted advice while students gain valuable experience managing real client work.

The Western Intellectual Property and Innovation Legal Clinic (WIPILC) meets the growing demand for affordable IP expertise from inventors, artists, entrepreneurs, start-ups and small businesses across Southwestern Ontario. The clinic provides guidance on patents, trademarks, and copyright. By working directly with clients, students learn to spot challenges, develop strategies, and deliver practical solutions that help innovators protect their ideas and bring them to scale.

Building on this success, Western Law is establishing the Western Business Law Program. The Program brings together our clinics, faculty research and community partnerships to expand opportunities for students, broaden access to legal support for small and growing businesses, and help fuel Canada's innovation ecosystem. Beyond the clinics, the Program will include:

- **Industry-focused faculty chairs and teaching scholars**, complementing our existing Mining Law Chair, and aligning legal expertise with Canada's most critical sectors.
- **Research that engages industry**, ensuring that our scholarship informs practice, regulation and innovation.
- **Modern curriculum innovation**, integrating AI literacy, digital tools, and technology-focused training so students graduate ready to navigate law, business and technology in an era of rapid change.
- **Leadership development**, equipping students not only to practice law but to graduate as leaders in business, law and technology.
