OPERATIONS REPORTS

Executive Director Report- Kiana Smith

Kiana Smith presented an update regarding the start of the school year, including updates regarding Child Nutrition and Transportation. Additionally, K. Smith shared that Tulsa Legacy Charter School was awarded a Charter School Growth Fund grant for a two year culture fellowship member. K. Smith also shared an update regarding safe entry and swipe card entries.

Principal Report- Carolyn Statum and Staci Hegler

Carolyn Statum shared updates from Primary Academy. Primary Academy staff members attended professional development with OKA+ in August in Edmond, Oklahoma. Additionally, C. Statum shared that the campus will be focused on the instructional strategy of making student thinking visible. At Primary Academy, there are eight new teachers this school year, including a Visual Arts teacher, a Restore Coordinator, and a Scholar Support Services teacher for math. Additionally, Primary Academy received a Healthy Schools Oklahoma grant, which includes funding for a community garden, rock wall, and future active learning lab.

Staci Hegler shared updates from Upper Academy. There are seven new roles at Upper Academy, including Social Studies and Science, as well as local talent such as Eddye K Allen for Visual Art, and Kode Ransom for Music.

Both campuses completed Back to School Night Friday August 12th (Primary Academy) and Monday August 15th (Upper Academy). Scholar school supplies were provided for all PK-8th graders this year.

Keystone and RFP Process Fall 2022

Kiana Smith shared an update regarding Child Nutrition for the district. Tulsa Legacy and Keystone will be parting ways in December 2022. The district has begun the RFP Process for finding a new child nutrition program provider.

New Teacher Contracts

Kiana Smith shared an updated personnel report list. New Legacy Builders will not be receiving the \$2000 return bonus. A vote was conducted and is detailed in the action items below.

2022-2023 Budget
