

## Privacy Policy

At Auqvian AB, we prioritize privacy and are committed to maintaining a transparent approach in the handling of your personal information. Our privacy policy outlines the methods we employ to process and safeguard your personal data.

### Purpose of Data Processing

At Auqvian, we process the information provided by you to manage administrative, accounting, and tax requirements for the services requested and to communicate about our products and services, subject to your consent.

### Data Retention Period

We retain your data for as long as our business relationship lasts and for as long as required to comply with our legal obligations. For example, accounting records are retained for seven years in accordance with the Swedish Accounting Act (bokföringslagen). When data is no longer needed for these purposes, it is deleted or anonymised.

### Legal Basis for Data Processing

The processing of your data is based on the following legal grounds under Article 6 of the GDPR:

- Performance of a contract for the provision of requested services (Article 6(1)(b)).
- Compliance with our legal obligations, such as accounting and tax requirements (Article 6(1)(c)).
- Your consent, where you have agreed to receive marketing communications (Article 6(1)(a)).

### Data Sharing

We do not sell your personal data. We may share your data with third parties who process it on our behalf, including providers of IT and cloud services, customer relationship management tools, and accounting services. These parties act as our data processors and may only process your data on our instructions and under a data processing agreement.

We do not transfer your personal data to countries outside the EU/EEA.

### Your Rights

You have the right to confirm whether Auqvian is processing your personal data. You also have the right to:

- Access your personal data.

- Correct inaccurate data.
- Request deletion of data when it is no longer necessary.
- Request restriction of data processing under certain conditions.
- Object to data processing for reasons related to your specific situation.
- Receive your personal data in a structured, commonly used and machine-readable format, and have it transferred to another controller where technically feasible (data portability).

To exercise these rights, please contact us at the email address provided above. To protect your data, we may ask you to verify your identity before we act on your request, but only where we have reasonable doubt as to who you are.

### **Consent Withdrawal**

You have the right to withdraw your consent at any time, without affecting the legality of the processing based on consent before its withdrawal.

### **Right to Lodge a Complaint**

If you believe that we process your personal data in breach of applicable data protection law, you have the right to lodge a complaint with the supervisory authority. In Sweden, this is the Swedish Authority for Privacy Protection (Integritetsskyddsmyndigheten, IMY), [www.imy.se](http://www.imy.se).
