2. Types of Data Collected

We collect the following categories of information:

1. **Personal Information** – Data that identifies you as an individual, such as name, email address, postal address, telephone number, payment details, or other identifiers you voluntarily provide.
2. **Usage Information** – Details about how you interact with the Services, including pages viewed, actions taken, time spent, and referral links.

3. **Technical Information** – Device and connection data such as IP address, browser type, operating system, unique device identifiers, language preferences, and cookies or similar tracking technologies.

Unless stated otherwise, providing Personal Information is mandatory to access core features. Failure to provide such data may limit functionality.

3. Cookies and Tracking Technologies

We use **cookies**, web beacons, pixel tags, and similar technologies (collectively, "Cookies") to collect Usage and Technical Information, enhance user experience, remember preferences, and analyze traffic. For details, please review our separate **Cookie Policy**.

4. Purpose & Legal Basis for Processing

We process your information to:

Comply with legal obligations and enforce our Terms	Legal obligation
Send marketing communications (with opt-out)	Consent (Art. 6 (1)(a))

Where consent is the legal basis, you may withdraw it at any time without affecting the lawfulness of processing based on consent before withdrawal.

5. Sharing & Disclosure of Information

We may share your data:

- **Service Providers** – With trusted vendors (e.g., hosting, payment processors, analytics) who process data on our behalf under confidentiality agreements.
- **Legal & Compliance** – To comply with subpoenas, court orders, or other lawful requests; to protect our rights, property, or safety or that of users or others.
- **Business Transfers** – In connection with a merger, acquisition, financing, or sale of assets, subject to standard confidentiality protections.
- **With Your Consent** – For any other purpose disclosed to you and agreed by you.

We do **not** sell or rent your personal information to third parties for their own marketing purposes.

6. International Data Transfers

BrainBits is based in the United States. We may transfer and process your information in countries outside your own, including countries that may not provide the same level of data protection. Where required, we use standard contractual clauses or other approved mechanisms to ensure adequate safeguards.

7. Data Retention

We retain personal data only as long as necessary to fulfill the purposes described in this Policy, comply with legal obligations, resolve disputes, and enforce our agreements. When retention is no longer necessary, we securely delete or anonymize the data.

8. Data Security

We employ reasonable administrative, technical, and physical safeguards to protect personal information against unauthorized access, alteration, disclosure, or destruction. No Internet transmission or storage system is completely secure; therefore, we cannot guarantee absolute security.

9. Your Rights (GDPR & CCPA/CPRA)

Depending on your jurisdiction, you may have the following rights:

- **Access** – Obtain confirmation whether we process your personal data and receive a copy.
- **Rectification** – Correct inaccurate or incomplete data.
- **Erasure** – Request deletion under certain conditions ("right to be forgotten").
- **Restriction** – Limit processing in specific circumstances.
- **Portability** – Receive data in a structured, machine-readable format and transmit it to another controller.
- **Objection** – Object to processing based on legitimate interests or direct marketing.
- **Withdraw Consent** – Revoke consent at any time where processing is based on consent.
- **Non-Discrimination** (CCPA/CPRA) – Exercise privacy rights without discriminatory treatment.

10. Children's Privacy

The Services are **not directed to children under 18**. We do not knowingly collect personal data from minors. If you believe a child has provided us personal information, please contact us and we will promptly delete it.
