Opportunities to place ECC package policies span a broad range of operations. Most carriers will require at least 25%–50% of the insured's operations be environmental in order to be considered. Some of the classes that can be eligible for an ECC package include:

Facilities Package

Opportunities to place environmental facilities package policies span a broad range of operations. Some of the classes that can be eligible for a package include:

Environmental Products	Packing/Containers (storage tanks/tank components, drums, aerosol containers/filters)
Recycling Facilities	Construction Products (cement/plaster/concrete, asphalt, interior finishings)
Renewable Energy	Textiles (mills, paper, products, chemicals, synthetic)
Pollution Treatment, Monitoring/Control Equipment	Plastic/Rubber
Environmental Laboratories	Industrial Soaps/Detergents/Cleaners, Cleaning
Chemical (manufacturer, distributor, ingredients, blending, industrial and commercial products)	Sand & Gravel Facilities
Paint/Coatings	Packaging Facilities
Treatment Facilities (water, wastewater, salt water, produced water etc)	Composting Facilities
Auto, Aircraft, RV, & Watercraft Parts (non-critical)	Agricultural – Related Products (including chemicals)
Mining Equipment/Quarries/Foundries (facilities & equipment)	Ink, Dye, Commercial Printers
Waste Treatment, Storage, or Disposal Facilities (landfills, transfer stations)	Petroleum & Coal Products Manufacturing
