If your payment service provider (acquiring bank or payment processor) has enrolled you in SecureTrust by VikingCloud, check your email for welcome instructions.

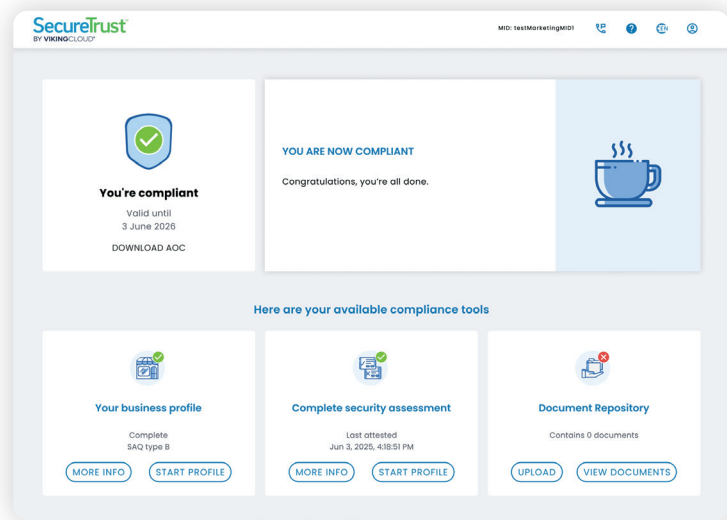

Have the following ready:

- Merchant ID number.
- Company name.
- Payment system details (device/software make & model, connection type: dial-up phone line, Wi-Fi, or wired internet).
- Third-party setup information—if you received help setting up, configuring, or managing your payment processing equipment, you may need to know how that equipment was set up.
- E-commerce payment form setup (if applicable).

TIP: When prompted, ensure the contact details for the person responsible for compliance reporting are up to date.

A tailored questionnaire based on your business type to validate compliance.

External Vulnerability Scanning (ASV):

If you have an e-commerce website or an internet connection that connects to business systems that store, process, or transmit payment card data, external vulnerability scanning may be required. Your SecureTrust by VikingCloud's dynamic portal will determine your scanning requirements based on your unique business profile. If your business requires external vulnerability scanning:

- Your online portal will guide you through the entire process of setting up your scans. It is important to scan the right location and/or website.
- You will receive notifications through every step of the scanning process, including alerts to log in and review your scan results when they are complete.
- Every 90 days, you must have a passing and attested scan within the portal to maintain your PCI DSS compliance.
