

Safer Farms Promotional Offers – Combined Terms & Conditions

Effective Date: 10 June 2026

These Terms & Conditions apply to the following Safer Farms promotional offers: (1) the “Be a Farmer for Longer – Win a Month of Meals” competition; and (2) the “Be a Farmer for Longer – Share your Pen Gate Photo– Prezzy Card Offer”.

Section A contains general terms that apply to both offers unless stated otherwise. Section B and Section C contain terms specific to each offer.

Section A – General Terms (applies to both offers)

1. Promoter

The promoter of both offers is Safer Farms of 14740 Route 52, RD3, Eketahuna, New Zealand, 4996. For any questions about either offer, contact info@saferfarms.org.nz.

Entry is open to New Zealand residents only. Directors, officers, employees, contractors, immediate family members, and anyone professionally connected with the Promoter of either offer may not enter unless the Promoter states otherwise. The Promoter may require proof of identity, age, and eligibility.

3. Marketing and Privacy

Participants may opt in to receive marketing communications and may unsubscribe at any time. Participation in either offer is not conditional on consenting to marketing unless clearly stated otherwise. By entering, participants acknowledge that the Promoter may collect and use personal information for administering the relevant offer, verifying eligibility, contacting participants, delivering prizes or rewards, and as otherwise permitted by law. Personal information will be handled in accordance with applicable New Zealand privacy law and the Promoter’s privacy policy [Privacy Policy | Farm Without Harm](#).

The purpose of data collection is to understand the impact of these initiatives on claims avoidance and cost reduction. ACC needs to know which businesses have participated so this requires the collection of New Zealand Business Numbers (NZBNs). The collection of NZBNs enables ACC to understand how many businesses the initiatives are reaching and compare results to businesses that didn’t participate. The data collected is only used to measure the effectiveness of the initiatives and not to monitor or evaluate the individual participating businesses.

The information provided to ACC will only be used for the purpose of estimating impact on the scheme and data collection is allowed (not required) under section 279 of the Accident Compensation Act 2001. 4. Invalid Entries, Verification and Disqualification

The Promoter may verify the validity of entries and entrants at any time and may reject or disqualify any entrant who tampers with the entry process, submits an entry that is incomplete or not in accordance with these Terms & Conditions, uses fraudulent or misleading details, submits duplicate or automated entries where not permitted, or engages in unlawful or improper conduct.

5. Liability

To the maximum extent permitted by law, the Promoter is not responsible for late, lost, misdirected, corrupted, incomplete, or inaccessible entries, or for technical failures affecting participation in either offer or delivery of any prize or reward. Nothing in these Terms & Conditions excludes, limits, or modifies any rights a participant may have under applicable New Zealand law that cannot lawfully be excluded, limited, or modified.

6. Cancellation, Suspension or Variation

If either offer cannot be run as planned for reasons beyond the Promoter’s reasonable control, including technical failure, fraud, or other causes affecting the proper conduct of the offer, the Promoter may cancel, suspend, or vary that offer to the extent reasonably necessary, subject to applicable law. The Promoter will not change material conditions after an offer has started except where permitted by law.

7. Governing Law

These Terms & Conditions are governed by the laws of New Zealand. Any disputes arising in connection with either offer will be subject to the non-exclusive jurisdiction of the courts of New Zealand.

Section B – Offer-Specific Terms: “Be a Farmer for Longer – Win a Month of Meals” competition

1. Promotion Period

The competition opens at 1.00 am on 10 June 2026 and closes at 12.00 pm on 31 July 2026 (NZT/NZST as applicable). Entries received outside this period will not be accepted.

To enter, an eligible person must complete the sign-up form available at Farmwithoutharm.org.nz and provide all required information. Each eligible person is entitled to one entry only. Incomplete or duplicate entries may be disqualified. No purchase is necessary to enter.

3. Prize

The prize is a 4 x weeks of a custom care package from Angel Delivery, delivered to any NZ-Post serviced address in New Zealand. Each week includes 5 x family-sized "Premium Main" and 1 x family sized dessert. The RRP of each 4-week custom care package is NZD\$1678.68. The prize is not transferable, exchangeable, or redeemable for cash. If the prize or any part of it becomes unavailable for reasons beyond the Promoter's reasonable control, the Promoter may substitute a prize of equal or greater value, subject to applicable law.

4. Draw and Winner Selection

Three winners will be selected by random draw from all valid entries received during the Promotion Period. The draw will take place no later than on 5 August 2026. The Promoter's decision on the validity of entries and the draw outcome is final, except for any rights that cannot be excluded under law.

5. Winner Notification and Claim

The winner will be notified using the contact details provided at sign-up within 14 business days of the draw. If the winner cannot be contacted, does not respond within 3 days, is ineligible, or cannot accept the prize, the Promoter may conduct a redraw. The Promoter may publish the winner's first name and city or other limited identifying details if this is stated in the promotional material or privacy notice and permitted by law.

Section C – Offer-Specific Terms: "Be a Farmer for Longer – Share your Pen Gate Story Prezzy Card Offer"

1. Offer Summary

Under this offer, eligible participants who submit a complete entry: the photo and story about the correct product/s, will receive one Prezzy Card loaded with NZD \$200, subject to these Terms & Conditions. The offer is limited to the first 100 valid complete entries received by the Promoter and each eligible person is entitled to one entry only.

2. Offer Period

The offer opens on 10 June 2026 and closes when 100 valid complete entries have been received.

3. How to Enter

To enter, a participant must, during the Offer Period, submit to the Promoter via email address to info@saferfarms.org.nz or via the online form on the Farmwithoutharm.org.nz site: (a) a photo of a Gallagher pen gate or a Kea trailer gate; and all required participant details requested by the Promoter.

4. Complete Entries

A complete entry is one that, in the Promoter's reasonable opinion: (a) includes all required participant details requested by the Promoter; (b) includes a clear photo of a Gallagher pen gate or a Kea trailer gate; and (c) is legible, lawful, and submitted in the format requested by the Promoter.

5. Reward

Subject to these Terms & Conditions, each participant whose valid complete entry is among the first 100 valid complete entries received by the Promoter will receive one Prezzy Card with a loaded value of NZD \$200. The reward is not transferable, exchangeable, or redeemable for cash, except to the extent required by law. Use of the Prezzy Card is subject to the card issuer's terms and conditions, including any applicable expiry dates, fees, and usage restrictions.

6. First 100 Valid Entries

The first 100 valid complete entries will be determined by the time and date of receipt by the Promoter, as recorded by the Promoter's systems. Entries will be reviewed for completeness and compliance with these Terms & Conditions before a participant becomes entitled to receive the reward. If an entry is later found to be invalid, incomplete, or non-compliant, the Promoter may disqualify that entry and the next valid complete entry received may become eligible.

7. Notification and Delivery

Eligible participants will be notified using the contact details provided with their entry. The Promoter will use reasonable efforts to send the Prezzy Card within a reasonable period after confirming eligibility. If a participant cannot be contacted, does not provide requested information, or does not comply with these Terms & Conditions, the Promoter may cancel that participant's entitlement and allocate the reward to the next valid complete entry received.

8. Submitted Content

By submitting a photo, the participant confirms that they either own the photo or have all rights and permissions necessary to submit it to the Promoter. The participant grants the Promoter a non-exclusive, royalty-free, worldwide licence to use, reproduce, publish, adapt, and communicate the submitted photo and story for the purposes of administering the offer and for the Promoter's marketing and promotional purposes, unless the Promoter states otherwise. Participants must ensure their submission does not infringe any third-party rights, including intellectual property, privacy, or confidentiality rights, and does not contain unlawful, misleading, offensive, or inappropriate material.
