

## Two Cents Farm Safety Competition Terms & Conditions

1. These terms and conditions relate to the Farm Without Harm Competition to submit your story about farm safety via the Farm Without Harm website. Information on how to enter and details of the prizes forms part of these terms and conditions. Entering the competition is deemed to be acceptance of the terms and conditions.
3. The Competition commences at 12pm 4 February 2026 and closes at 11.59pm 25 February 2026 (the 'Competition Period'). Submissions received outside of the Competition Period will not be accepted.

### Conditions of Entry

4. Employees (and their immediate families) of Safer Farms (owner of Farm Without Harm) and any companies associated with the Competition are ineligible to enter.
5. By submitting your story, you agree to allow Safer Farms to use this anonymously in subsequent marketing campaigns on our channels. Safer Farms will contact you to ask permission to use your name.

### Prizes

6. There are two prizes. Two winners will be drawn.
7. The names drawn will be allocated either a \$200 voucher from Silver Fern Farms, or a \$200 voucher from Alliance farms.

### How to enter

8. To enter, you must complete the form on the Farm Without Harm home page, supplying your name, email and details about your thoughts on farm safety. An incomplete form (with just name and email) will not be eligible to win a prize.
9. All entries are deemed to be received at the time of the receipt in to the Farm Without Harm website database.
10. There is an opportunity for an extra entry into the prize draw for those who sign up for Safer Farms/Farm Without Harm newsletters and Safety Alerts.

### Draw and Winner Notification

11. The prizes will be drawn at random on 27 February 2026. Winners will be notified by email from Safer Farms. If the winner has not responded within 72 hours another draw will take place.
12. Safer Farm's decision is final and no correspondence will be entered into.
13. Prizes will be awarded to the person named in the entry to the Competition.

14. Safer Farms reserves the right to change these terms and conditions without prior notice.
15. Safer Farms reserves the right to verify the validity of entries and to disqualify any entry (including the winning entry) which, in their opinion includes objectionable content, profanity or potentially insulting, inflammatory or defamatory statements.
