The main purpose of these valuations is to determine whether SVWC has adequate reserves to fund its contractual obligations to our residents. It also serves as an early warning of deficiencies in pricing structures to avoid a potential financial crisis.

AV Powell also awards the AVP Seal based on its actuarial study results for each fiscal year. The AVP Seal is a designation developed by AV Powell & Associates to indicate that its client's actuarial results place them in the top tier among its peer CCRCs during the fiscal year specified. Even though most of its clients are found to be in satisfactory actuarial balance, typically less than 40 percent meet the criteria to receive the AVP Seal.

We are pleased to announce that SVWC has once again received the AV Powell exemplary recognition seal. SVWC has received this seal for the past several years. This is just one of the tools that our management team and Board use to assure the short- and long-term financial success of our community.

The Woodworking Shop: A Community Asset

Need a broken chair fixed? A table refinished? A bookcase built? A lamp repaired? Forget the yellow pages. All these problems can be handled by SVWC's Woodworking Shop. Located across the street from the Fitness Center, the shop was added to the campus for residents' use in SVWC's early years. Residents Les Hubert (also the founder and initial editor of Westbury World) and Dick Tyler were its de facto managers/craftsmen. After their passing, they eventually were succeeded by George Burgess and Jimmie Harp.

George has been in the shop for 13 years. He developed an interest in woodworking late in life, stemming from his involvement in restoring an old barn. Jimmie joined George in the shop about a year later. He has had sawdust in his veins since he was a boy. Jimmie seldom finds a job too difficult. He was not even fazed by a resident's request to build a real coffin. (He did.)

In addition to individual building and repair projects for residents, George and Jimmie have built things for the entire community to enjoy, including the furniture in the Chapel, the puzzle tables in the Commons and Winchester Hall, and 10 outdoor benches for Mother Nature's Team.

The shop charges for the cost of materials. Labor is free, but donations, all of which go to the Fellowship Fund or the Employee Emergency Fund, are welcome. In 2020, donations totaled about \$2,000.

Any resident can use the shop. There are no fixed hours. Initially, it is best to contact Jimmie, ext. 739, to arrange entry and an orientation on the basic machinery.

Even though we have turned our clocks forward to Daylight Savings Time, and it is still dark when I awake in the morning, I am delighted that I am now greeted by bird song. Sometimes, I just listen, before getting up to start my day.
