## **ABOUT SPORT MANITOBA**







# STATEMENT OF OPERATIONS BUDGET







## **SPORT**

To meet the priority areas for the upcoming year, the Sport Unit continues to evolve our staff position descriptions to better serve our sport community.

We maintain our commitment to prioritize efforts for Manitobans who are underrepresented in sport. Within the organization, Sport Manitoba continues work within the Equity, Diversity, Inclusion and Belonging Committee to support the members of our organization to ensure the diversity of our staff is our strength.

This year will begin with our work to implement the recommendations of Sport Manitoba's Two-Spirit, Transgender, Nonbinary + Committee to support participation and inclusion for 2SLGBTQ+ participants.

We will expand our partnership and working relationship with Canadian Women and Sport to extend the support to our sport partners for increasing female participation in sport in all areas, including athletes, coaches, officials, and board members.

We will continue to work with our new Canadian partners to implement processes that safely welcome new Canadians to experience the benefits of participating in sport.

Working directly with the parasport community, we will collaborate with various organizations to increase awareness and opportunities for athletes with physical and intellectual disabilities.

Implementing Sport Manitoba's strategic planning around reconciliation and the five sport-specific calls to action will be a focus this year. At the same time, continued work to strengthen our relationships with Indigenous communities and organizations will grow through dedicated staff initiatives.

With the 2022 and 2023 Canada Games taking place less than nine months apart, the demand for Sport Manitoba Performance and athlete development services has never been greater. Performance is currently working with over 25 different teams, and 250 athletes and coaches on an ongoing monthly basis to help prepare them for upcoming competitions, primarily focusing on strength and conditioning, testing, nutrition and mental skills services. In addition to on-site delivery, the performance team continues to host sport-specific combines, educational sessions, and provide regional identified athletes with high-performance guidance and support.

Games' top priority through the 2022-2023 year will be to deliver an exceptional experience during an unprecedented run of two Canada Games events. The focus will be on providing leadership and guidance to PSOs to send our best contingent of athletes and achieve desired outcomes. Games will develop a cross-disciplinary strategy that makes effective use of Sport Manitoba resources so that coaches can access an expert Integrated Support Team conducive to driving performance.

Sport Manitoba Coaching will continue to offer online delivery of our NCCP Multisport modules. We project in-person courses will not be our main delivery method going forward as the opportunity to offer these courses online will reduce any accessibility issues and is much more convenient for coaches across Manitoba. Respect in Sport will be a focus for our PSOs to increase the number of coaches who are actively certified.

## **SPORT**

We will also be focusing on officials development through the upcoming year with the redevelopment of the ReferEASE program, which fosters respect, empowers officials, and provides funding for training and evaluation of Manitoba officials.

Many of the other programs that Sport Manitoba Coaching offers, such as Female Mentorship, Bison Transport Sport LeadHERship Series, and professional development, will proceed with the online delivery allowing us to maintain high-quality services.

- Quality programs and services for athletes, coaches, and officials are planned and provided through alignment of priorities, grants, programs, and staff
- Enhanced interaction and engagement via meetings, workshops, and communications leads to increased training opportunities and growing networks with PSOs, partners in sport, and strategic alliances
- Joint initiatives with PSOs and partners in sport to address key priorities are facilitated
- New PSO strategies are developed and supported for PSO memberships to grow and recover from the pandemic
- Organizational capacity of targeted PSOs are improving
- Manitoba's sport environment is increasingly welcoming and inclusive



## **MARKETING**

The Marketing Unit creates and manages Sport Manitoba's overall brand experience, aims to drive revenue generation through the promotion of our program and service offerings, and promotes the many opportunities for sport participation and the positive impacts sport has on our communities. We work collaboratively within our organization and with our sport partners to create powerful and engaging campaigns, initiatives, and events to reach Manitoba's diverse audiences.

Content creation has been and will continue to be a focus for Sport Manitoba in 2022-2023. Through our website, social media channels, and advertising partners, original content is produced, shared, and evaluated to determine success and fit for future plans. Getting back to in-person settings will be key to maximizing the impact of our events, but if necessary, online delivery has proven successful and the Marketing Unit has a demonstrated ability to pivot when required.

The unknowns around pandemic restrictions may continue to impact Sport Manitoba's revenue generation potential this year, from both facility services and sponsorship standpoints. Welcoming members, clients, patients, and the public back to our facility and attracting new facility users will be a priority. Further focus on connecting with our Exchange District neighbours and creating pandemic-friendly fundraising opportunities will be a priority this year, as will key messaging identified in MAPS, including safe sport, the dangers of early sport specialization, the recruitment, retention, training, and mentorship of officials, access to sport initiation programs, and the value of sport to our communities.

## FINANCE AND OPERATIONS

The Finance and Operations Unit provides oversight of the financial health and facility operations of Sport Manitoba. It is responsible for internal financial management, adopting best practices, and developing budgeting, financial reporting, and management practices. They provide accurate, reliable and effective financial reporting and are entrusted with the financial and capital resources, including facilities. This year, projections and cash flows will be required on a regular basis as we come out of the pandemic and offer our revenuegenerating programs, services, and events.

The Unit provides leadership with financial information necessary to make strategic decisions at any time during the fiscal year, and supports all audit and compliance obligations. This includes managing and improving operations by measuring and reporting regularly on key numbers that are crucial to the success of the organization, such as all revenue streams and expenses. Moving forward, Sport Manitoba will be required to measure and report on these key numbers on a more regular basis.

The activities expected from the Unit cover a wide range, from accounting, to providing information, to assisting managers in making strategic decisions. In addition, it provides and supervises the management of the physical operation of the Sport Manitoba facility and the provision of administrative services to sport. This provides timely, efficient, and cost-effective services. It also provides direction and coordination for developing and maintaining Sport Manitoba's information technologies and systems, ensuring that technologies meet the needs of the users.

The Finance and Operations Unit provides the financial leadership necessary to assist our sport partners with monthly bookkeeping and audit preparation, as well as to ensure the overall financial health of the organization. This area will be particularly important in 2022-2023 as we continue to recover from the pandemic.
