

Industrial Services M&A Insights

A Very Unique Third Quarter

Q3 2024 marked an exciting time in the M&A market: there was a significant amount of election uncertainty, the first fed funds interest rate decrease was affected in mid-September, and the geopolitical backdrop continued to be unstable at best, with major conflicts continuing in the Middle East and Eastern Europe. Despite all that, we would wager that the biggest factor in understanding this last quarter is understanding what's going on with private equity firms, which are the predominant drivers of all industrial services M&A activity. The fact that rate cuts in Q3/Q4 have been so telegraphed by the fed has led to private equity firms slowing down add-on activity and instead focusing on integration of existing add-ons to get ready to go to market in late 2024 or early 2025 alongside **lower rates**. We expect this to contribute to a very slight "hangover" period over the next few quarters where there is a lower amount of M&A activity. This would predominately be felt in the market as quicker passes from platforms that are in market or preparing for market, while platforms that are in growth mode should still be as acquisitive as ever, especially given lower interest rates being more conducive for transactions.

Looking Forward to Q4 and 2025

We expect the M&A market to remain healthy through the near- to medium-term. The fed's indication to continue cutting interest rates through 2025, along with (now, as of mid-November) having election certainty, are the two strongest tailwinds. We also expect president-elect Trump and his administration to have a slightly more conductive environment for M&A and lighter, more targeted regulation. We also expect a number of industry-shaping platform exits / acquisitions to occur in the near-term now that decreasing



- Industrial services M&A was down 5% YoY and 24% MoM in Q3 2024 as platforms prepare for lower interest rates

GenNx360 Capital Partners Acquires Shenandoah Industrial Solutions (KLH Capital)





