IFMA World Workplace: Thoughts and Takeaways

What a great week in Denver back in September with many of you at IFMA World Workplace! The energy of attendees and exhibitors throughout the conference was fantastic. There was optimism from everyone we spoke with across industry segments – from diversified facilities services, technology platforms, elevator services, janitorial services, electrical services, to goods. Compared to last year, the number of conversations around labor decreased significantly, as labor markets have eased slightly and operators have had time to formulate and implement strategies to retain current, and recruit new, talent. **Technology was again a popular topic** through the conference and presentation speakers – as consolidation in the industry continues at pace, technology is important to scale as providers, and valuable for insights and real-time data as buyers and facility managers. Based on conversations in the hall, the conference once again seemed to be a useful tool for both service providers and buyers, with strong turnout across the board and countless connections made. Many thanks to all that made the trip.

Q3 2023: Industrial Services M&A is a Beacon of Light in the Broader, Slower M&A Market

While the broader M&A market has slowed down, industrial services businesses continue to trade at healthy valuation levels. M&A volume in the third quarter demonstrated resilience in the face of rising interest rates and a tough macroeconomic backdrop, with total transaction count increasing 37.1% compared to Q2 2023 and 9.1% compared to Q3 2022. The majority of transactions this quarter were private equity platform add-ons, which we have seen being increasingly funded with combinations of cash-on-hand, revolving lines of credit from the platform, rollover equity, and to a much lesser extent increases in financing facilities.

I think we've seen the first evidence that prices have come off on M&A in America, which is the hottest market in our business for acquisitions. And I say that in part because I think the cost of debt, your point...if we're bidding against private equity who don't have synergies and they have very high cost of debt, that is definitely crimping their style to a degree.



Key Quarterly Takeaways

- Although there were 13 platform investments made this quarter, they are challenging given the current financing market.
- We continue to see an increase in one-on-one negotiations, with sellers skipping the broader marketing process as buyers pre-empt directly to sellers.
- Although there are macroeconomic concerns, our clients are still achieving strong and growing levels of profitability.
- Buyers are over-equitizing deals, with the average private equity transaction now more than 50% equity.

Keter Environmental Services (TPG) Acquires Waste Harmonics (Arcapita)





