Industrial Services M&A Insights

Q2 Update: Growing Strategic Interest

The industrial services M&A market continued its strong run in Q2, with transaction volume well above the broader M&A market and momentum carrying over from a busy first quarter. Buyers, both private equity and strategic, are aggressively pursuing opportunities, backed by significant dry powder and a persistent appetite for roll-up strategies across environmental services (15 deals this quarter), waste management (19 deals this quarter), and facility services (59 deals this quarter).

For quality sellers, the current market backdrop is proving highly favorable. In our active sell-side mandates this quarter, valuations remain strong, driven by buyer competition for premium assets and a notable shortage of quality companies in market.

Notably, a few unique areas where buyers are placing value include: safety performance (mod rates under 1 especially), attachment rate (ratio of turning install work into ongoing service work), and specific end-market mix (data centers, healthcare, semiconductor, among others). These factors not only support elevated purchase multiples but also give owners leverage in choosing their ideal partner.

While buyers remain disciplined on lower-quality targets, often extending diligence and sharpening terms, the overall climate is constructive for well-positioned sellers. With the market not overly crowded, every quality asset that comes to market is getting a strong look from a deep bench of acquirers, increasing the odds of multiple, compelling offers.

Where Does The Market Go From Here?

The short answer is we see no reason for a slow down in M&A. Rate cut expectations are high, and dry powder remains high. A few segments we're watching closely where M&A is picking up include commercial (and residential) roofing, commercial HVAC, environmental services, and industrial maintenance.



Last quarter, we've done some other normal tuck-in acquisitions, and we have one fairly sizable one that we're hopeful we're going to get closed probably between Q3 and Q4...But [regarding the] pipeline, the pipeline remains strong.



Key Quarterly Takeaways

- Environmental services demand is a stark takeaway this quarter, there is an extremely high level of interest in liquid and industrial waste transportation, collection, and treatment businesses
- Scarcity drives competition with a lower overall number of deals coming to market, buyers are spending time digging into services business
- Transactions were up 14.5% QoQ, and 60% of deal activity came from platform add-ons
- Across our active sell-side mandates, feedback from the market has been overwhelmingly positive, and allowed sellers with many potential options as partners to choose the best fit

Ares Management Acquires Landscape Workshop (Carousel Capital)



On May 19th, Landscape Workshop ("LW"), a Birmingham, AL-based full-service grounds-maintenance provider across the Southeastern U.S., was acquired by Ares Management ("Ares"), a Los Angeles, CA-based private equity firm. Ares acquired the platform from Carousel Capital after a 5-year hold period. The partnership is expected to support expansion of LW's regional footprint and growth through additional acquisitions. Affordable Waste Management

On April 1st, Affordable Waste Management ("AWM") was acquired by Valicor Environmental Services ("Valicor"), a private equity-backed provider of non-hazardous wastewater treatment services. AWM is a Louisville-area wastewater and sludge-hauling operations of Grasslands Environmental Services. Based in Louisville, AWM provides leachate and sludge reclamation, hauling, processing and disposal, recycling more than 50 million gallons of leachate annually. The acquisition expands Valicor's Midwest footprint; the company now operates 28 facilities across 14 states and recycles over 350 million gallons of wastewater each year.
