The CBRE Global Real Assets Fund ('the Fund') is a daily liquid[#], actively managed 'Fund of Funds' strategy that combines the best of both worlds - a globally diversified, institutional quality portfolio of listed and unlisted real estate and infrastructure investments - accessible in a single transaction.

With a target asset allocation of 70% listed securities and 30% unlisted securities, investors benefit from the expertise of CBRE Investment Management's specialist teams, who actively manage the Fund's four underlying strategies across private real estate, private infrastructure, and listed real assets.

Investment Objective

The Fund's objective is to outperform (after management fees and costs, but not performance fees) the Reserve Bank of Australia (RBA) Official Cash Rate plus 5% p.a. over rolling 5 year periods. The Fund is unhedged to AUD*.

Investment Process

CBRE Investment Management follows a disciplined, research-led process built on three strategic pillars:
