THE FOOD BANK PROVIDED OVER 705,863 POUNDS OF FOOD TO TERRY'S TABLE FOOD PANTRY. BY HELPING MEET PEOPLE'S PHYSICAL NEEDS, COMPASSION UNITED NURTURES THEIR EMOTIONAL AND SPIRITUAL NEEDS. TERRY'S TABLE FOOD PANTRY IS LOCATED IN CUT AND SHOOT, TEXAS.

COMPASSION UNITED HOSTS EVENTS SIX DAYS PER WEEK WHERE VOLUNTEERS AND PROGRAM LEADERS INTERACT WITH THE HOMELESS IN MONTGOMERY COUNTY, TEXAS. AT THESE EVENTS, FOOD AND CLOTHING ARE PROVIDED TO OFFER RELIEF. FOR THOSE WHO ARE READY TO MAKE A CHANGE IN THEIR LIVES, COMPASSION UNITED OFFERS OPPORTUNITIES FOR EMPOWERMENT THROUGH TRANSITIONAL LIVING PROGRAMS. IN THESE PROGRAMS, SHELTER, TRANSPORTATION, EDUCATION, AND MENTORSHIP ARE PROVIDED TO THE MEN AND WOMEN. PROGRAMS TO THE HOMELESS SERVE APPROXIMATELY 72 PEOPLE A DAY.

ON JULY 15, 2019, THE CITY OF CONROE, TEXAS CONTRIBUTED 5 ACRES OF UNDEVELOPED LAND TO CU. LOCATED AT 350 FOSTER DRIVE, THE SITE IS APPROXIMATELY TWO MILES SOUTH OF DOWNTOWN CONROE. THE ORGANIZATION AGREED TO UTILIZE THE PROPERTY TO PROVIDE LOW-INCOME HOUSING, HOUSING FOR THE HOMELESS, AND PROVIDE RELATED SERVICES NO LATER THAN JULY 15, 2024. THE SITE IS CALLED MIRACLE CITY.

THE CITY OF CONROE HAS THE RIGHT TO REGAIN THE TITLE TO THE PROPERTY IF CU DOES NOT MEET THESE TIME LIMITS OR DOES NOT CONTINUE TO OPERATE AS A NON-PROFIT SERVING THE HOMELESS. THIS REVERSIONARY INTEREST EXPIRES ON DECEMBER 31, 2039. IN THE EVENT THE CITY BELIEVES THE ORGANIZATION IS NOT IN COMPLIANCE WITH THE REQUIREMENTS OF THE CONVEYANCE, THERE ARE NOTICE AND RIGHT TO CURE PROVISIONS IN THE DEED. CU ESTIMATED THAT THE VALUE OF THE LAND DONATION WAS \$217,800. DUE TO CONDITIONS ON THIS LAND, IT IS NOT RECOGNIZED ON THESE FINANCIAL STATEMENTS (SEE NOTE 8).

CU PLANS FOR THE SITE TO INCLUDE AN INNOVATIVE, TRANSFORMATIONAL COMMUNITY CONSISTING OF TRANSITIONAL HOUSING, SUPPORT SERVICES, AND EMPOWERMENT OPPORTUNITIES. THE FIRST BUILDING IN MIRACLE CITY, THE EMPOWERMENT BUILDING, WAS COMPLETED IN APRIL 2022. IT IS A STEEL FRAME, 5,500 SQUARE FOOT BUILDING THAT HOUSES THE CHOP AND FRESH START EMPOWERMENT CENTER AS WELL AS ADMINISTRATIVE OFFICES. ITS TOTAL COST OF APPROXIMATELY \$1,130,000 INCLUDES CONSTRUCTION COSTS PLUS PERMITS, UTILITY CONNECTIONS, ARCHITECTURAL FEES, ENGINEERING, LIABILITY INSURANCE, BANK FEES AND SITE WORK.
