

2026-NYS Indoor 900/1800 State Championship Match

Must Be Conducted Between 1/1/2026 - 3/31/2026

FREQUENTLY ASKED QUESTIONS

Q: Are there any club requirements?

A: Yes, the match must be shot at a club located in NYS.
NYSRPA club affiliation is required.

Q: What are the dates of the event?

A: The match must be conducted between 1/1/2026 and 3/31/2026. Scores must be returned to the NYSRPA Pistol Chairman no later than 4/10/2026.

Q: What are the different formats a club can offer?

A: The range must be Indoor and 50 feet in length with turning targets.

Q: What targets are used for this match?

A: New official NRA targets, Slow Fire B-2 & Timed/Rapid Fire B-3

Q: What is the course of fire?

A: The course of fire for each 900 shall be a total of 3 Slow Fire, 3 Timed Fire and 3 Rapid Fire targets. It shall be at the discretion of the venue if that consists of a traditional 900 sequence (SS, TT, RR, NMC) or 3 National Match Courses of fire. Please note center fire slow fire must be 5 shots per target.

Q: Over how many days may I fire the event?

A: The match must be fired between 1/1/2026 and 3/31/2026. There is no limit on the number of days for the event. You may fire 3 separate NMCs on three different dates to constitute a 900. For example, you may have a weekly 300 League, those targets and scores may be used for 3 consecutive weeks. Alternatively, you may schedule a dedicated 900, or 1800 event. It is entirely up to the match director.

Q: Can I use my league rules for this event?

A: No! Guidelines provided in the bulletin and FAQ are to be followed. While this is not a registered event, we will follow NRA/CMP firing procedures for a precision pistol/bullseye event.

Q: What is the minimum number of shooters at one time?

A: Shooters cannot shoot alone! There must be a minimum of two persons in attendance when fired, the shooter and an RSO, who can also be the person calling the line.

Q: How many events can a shooter compete in?

A: A shooter may compete in as many events as they choose. Shooters must declare their score will count in advance of firing to the Match Director. If multiple entries are received, only the only the first event shall be entered.

Q: Can I shoot multiple entries if using different sights?

A: Yes, shooters can enter both matches if they choose, but only one entry each for 900 22 Only and 1800 2-Gun.

Q: Is there a team event?

A: Yes, this will be a paper match. 4 Person teams will be accepted and computed oU the NMC score. If the format submitted consists of 3 NMC scores, the 3rd NMC score will be used for team score. The same will apply to the 1800 format, it will be an aggregate taken from both 900 following the same procedure. Teams will not be classified, they will be judged exclusively by the combined team score.

Q: What are the scoring and target retention policies?

A: All targets must be scored, verified and signed by the RSO, team captain or match director. They must be retained by the Match director after scoring or verification in case NYSRPA verification is needed. They are to be retained by the match director until the final results for the state-wide event have been approved by the NYSRPA Pistol Chairman.

Q: Who may shoot in the event?

A: Anyone who can safely and legally compete. Junior shooters are encouraged to participate. Please adhere to NYS Rules & Regulations for anyone under 21 that will be participating (Example: Parent or guardian present while the junior is shooting).

Q: Who is eligible for state awards?

A: Members of NYSRPA or the shooters home state association, for out of state shooters, is required to win class and special awards. In order to win the NYS Champion Award, the shooter must be a NYS resident and a NYSRPA member.

Q: What are the match fees?

A: Local match fees are at the discretion of the match director and club. NYSRPA will require you send a \$5 fee per shooter per match (i.e. 900 or 1800) and a \$5 fee per team with your scoring report. Checks are to be made payable to NYSRPA.

Q: How are shooters classified for the event?

A: We have included a flowchart for you to follow when classifying shooters. In short NRA/CMP classifications come first, Temporary NRA/CMP classifications come second and League averages third. All unclassified shooters will be placed in the Master class. Match Directors are responsible for verifying classifications.

Q: What awards will be given?

A: All awards for this event will be in the form of a certificate. Overall Winner, NYS Champion, High Master, High Expert, High Sharpshooter and High Marksman.

Q: What Team awards will be given?

A: All awards for this event will be in the form of a certificate. Awards will be given for High Team as long as at least 2 teams competed in the match format. Team eligible formats are: 900 22 Only and 1800 2 Gun.

Q: What special categories awards will be given?

A: All awards for this event will be in the form of a certificate. High Grand Senior, High Senior, High Junior, High Woman, High 2 handed junior.

Q: How do I record my scores?

A: Utilize the spreadsheet provided by NYSRPA. If not possible then send all scorecards to Paul Agneta, 175 Plank Road, Troy, NY 12182
