Specialty Referrals

Alternate treatment rule Sometimes there are several ways to treat a dental problem, all of which provide acceptable results.

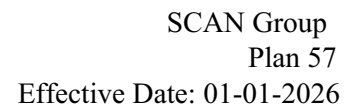
