

MINUTES FROM

THE EXTRAORDINARY GENERAL MEETING IN

PROTECTOR FORSIKRING ASA

The Extraordinary General Meeting (EGM) of Protector Forsikring ASA was held at the company's premises at Filipstad Brygge 1, Oslo, 8 September 2025.

Jostein Sørvoll, Chair of the Board, opened the Extraordinary General Meeting. Registration of attending shareholders and proxies was carried out. Shareholders who had not notified the company of their intention to participate in the Extraordinary General Meeting within the specified deadline were not allowed to participate.

The record of attending shareholders with voting rights showed that 47,104,586 shares out of the company's total 82,500,000 shares were represented. Thus, 57.1% of the total share capital was represented, adjusted for the company's 65,173 own shares. The list of attending shareholders with voting rights is attached to these minutes as Appendix 1.

The Nomination Committee was represented in the meeting by Andreas Mørk.

The Chief Executive Officer was absent with apologies. The company's CFO, Ditlev de Vibe Vanay, had been appointed to act as his deputy.

Jostein Sørvoll was unanimously elected as the chair of the meeting.

Andreas Mørk and Amund Grønvold Skoglund were unanimously elected to co-sign the minutes together with the chair

2. Approval of the notice and agenda for the meeting

No comments were made regarding the notice and agenda. The Extraordinary General Meeting was thus unanimously declared legally constituted.

3. Election of member of the Board
