This Cookie Policy explains how Tenuta Casucci (“we”, “us”, “our”) uses cookies and similar technologies on our website, in compliance with the EU General Data Protection Regulation (GDPR), the ePrivacy Directive, and guidance issued by the Italian Data Protection Authority (Garante per la Protezione dei Dati Personali).

1. What are cookies?

Cookies are small text files that websites place on your device (computer, smartphone, tablet) when you visit them. Cookies help websites function properly, improve user experience, and provide information to website owners.

2. Types of cookies we use

a) Strictly necessary cookies

These cookies are essential for the operation of the website and cannot be disabled. They are usually set in response to actions such as filling in forms or setting privacy preferences.

Legal basis: Legitimate interest / technical necessity

Consent required: No

b) Analytics cookies (Google Analytics)

We use Google Analytics to collect aggregated and anonymised information about how visitors use our website (e.g. pages visited, time spent on site, traffic sources).

- IP addresses are anonymised
- Data is used for statistical purposes only
- Information is not used to identify individual users

Provider: Google LLC

Data transfer: Data may be transferred outside the EU (e.g. to the USA), subject to appropriate safeguards such as Standard Contractual Clauses.

Legal basis: Consent

Consent required: Yes

c) Marketing cookies (Brevo – email marketing)

We use Brevo to manage email communications and newsletters. Cookies may be used to:

- Track email campaign performance
- Understand interaction with email content (e.g. opens, clicks)

- Improve relevance of communications

These cookies are only activated if you provide explicit consent.

Provider: Brevo (Sendinblue SAS)

Legal basis: Consent
