

## Terms of Use

*Last updated: [08 / 09 / 2025]*

These Terms of Use (“**Terms**”) govern your access to and use of the website and any materials, downloads, forms, and embedded services available at [**thraceaerialtech.com**] (the “**Site**”), operated by **Cloverfield LTD** (“**Cloverfield**,” “**we**,” “**us**,” or “**our**”). By accessing or using the Site, you agree to be bound by these Terms. If you do not agree, do not use the Site.

### 1) Audience & Purpose of the Site

The Site targets professional and governmental users evaluating counter-UAS (C-UAS) solutions and services. Content is provided **for general informational purposes only** and **does not constitute** an offer, technical advice, operational instruction, or a commitment to sell or deploy any product or service.

### 2) No Operational Use / Emergencies

The Site is **not** an incident-reporting or emergency response channel. Do not rely on the Site for time-critical or safety-critical decisions. If you face an urgent situation, use official emergency contacts and your internal procedures.

### 3) Lawful Use Only (Jamming/Interceptors)

We may assign these Terms; you may not assign them without our prior written consent. Our failure to enforce a provision is not a waiver. **Force majeure** applies to events beyond our reasonable control.
