# **My Custom Sleep Journey Refund Policy**

## **Program-Specific Refund Guarantees**

## **Client Responsibilities for Refund Eligibility**

## **Refund Request and Approval Process**

## Refund Payment Processing (3 Working Days)

Once a refund request has been officially approved:
