MINUTES

The City of Loogootee City Council convened in special session February 19, 2025, in the meeting room at the City Hall located at 401 JFK Ave, Loogootee, Indiana.

The meeting was called to order with the Pledge to the Flag at 6:01 pm.

***OPENING BIDS FOR CCMG***

A motion was made by Carroll to allow Midwestern Engineers Inc to accept the winning bid on behalf of the city after review of the bids, seconded by Dave. All in favor, motion carried.

***SALARY AND WAGE ORDINANCE MODIFICATIONS REQUEST***



**ESSENTIAL BUSINESS**




With no further business, the meeting was adjourned at 6:16 pm with a motion made by Carroll and seconded by Dave. All were in favor and the motion passed.
