Reports were given by Bo, Justin, Eric, and Jimmy.


**ESSENTIAL BUSINESS**


An executive meeting was announced for the Board of Works to be held on Thursday, February 13, 2025, at 6 PM with a special meeting to follow in regards to personnel.
