CITY COUNCIL
REGULAR MEETING
MARCH 10, 2025
MINUTES

The City of Loogootee City Council convened in regular session March 10, 2025, in the meeting room at the City Hall located at 401 JFK Ave, Loogootee, Indiana.

The meeting was called to order with the Pledge to the Flag at 6:38 pm.

Roll call was taken. Council members present were Councilman Mark McAtee, Councilman Mike Engleman, Councilman David Smith, Councilman Jeremy Holland, and Councilman Carroll Rayhill. Also present were Attorney Steven Teverbaugh and Clerk Treasurer Lori Carrico. Mayor Ader was not present.

The minutes from the prior meetings were reviewed and approved with a motion made by Dave, seconded by Carroll. All in favor, the motion passed.

Claims from February were presented and approved with a motion by Carroll, seconded by Dave. All in favor, the motion passed.

NEW BUSINESS

ANNUAL SAMPLER MAINTENANCE

Bo requested approval for the annual sampler maintenance provided by Gripp. A motion was made by Carroll to approve that request, seconded by Mike. All in favor, the motion carried.

TREES AT CITY PARK

Bo presented the Council with quotes for the removal of three trees at the city park that he believes need to be removed due to liability issues these trees present. A motion was made by Jeremy to accept the quote from Keller Tree Service, seconded by Mike. All in favor, the motion passed.

CITY STREET WEIGHT LIMIT

Bo spoke to the Council about several complaints he has received from the public about instating weight limits on city streets. Audience members addressed the council about their concerns with the heavy equipment and trucks that are using the city street for the construction of the new Country Court V subdivision. After much discussion, the Council stated that they would have the city attorney look into creating an ordinance pertaining to city street weight limits. No motion was made.

COMPREHENSIVE PLAN

The council reviewed a proposal that was submitted to them by HDMG to develop a comprehensive plan for the city. The proposal was quoted at a price of \$30,000 which would be paid for with \$20,000 in grant money and \$10,000 in EDIT funds. The council tabled the issue to further review.

COUNTRY COURT V PAY APPLICATION #6

Clerk Treasurer Carrico requested the Council's approval to pay the latest pay application on the Country Court V project. A motion was made by Carroll, seconded by Jeremy. All in favor, motion carried.
