2. Diplomatic ESG Coding

ESG must be elevated beyond checklists into a symbolic diplomatic language that can operate across legacy, finance, and planetary governance.

3. Symbolic Infrastructure

Yachts, conservation grants, cultural collaborations: these must be reconfigured into interfaces of governance, not isolated gestures of benevolence.

4. Legacy-Layered Stewardship

From UHNW families to sovereign wealth entities, the marine space must evolve into a multi-tiered legacy structure, capable of sustaining symbolic and operational authority over time.
