





Statutory Functions Exploration Update - On hold

Since the last Board in early December 2024, the English Devolution White Paper has been published. This outlines several transport functions envisaged for different types of Strategic Authority alongside other major local government reform. Individual local authorities will be considering what new opportunities are presented by different structures and are the best fit for their communities.

Given the level of change and the emerging clarity around devolution of powers, this is not the time for the region to be pursuing formal statutory status for its sub-national transport body. EEH envisages working in collaboration on a pan-regional basis with strategic authorities, who will have funding and powers devolved directly to them. These are exactly the discussions that are now underway within the Transport East and Transport for the South East areas, where a number of places have been included on the Devolution Priority Programme.

Alongside exploring possible statutory powers and functions, the EEH Business Unit has commissioned work on different delivery models and how well these might meet the aspirations of the Board.

At present, the existing 'as is' arrangement appears to be the most appropriate delivery model for EEH to work as a strategic partner as the region navigates through the uncertainty of local government reform transitions. The option spectrum for delivery models can be revisited at an appropriate time for the region, as the Board desires. EEH will continue working with our local partners to establish the best way we can support as a devolution partner, learning from other regions, recognising our own unique opportunities (such as East West Rail) and drawing on our own strengths around convening and collaboration.
