# 2.0 Meeting Notes – February 1, 2024

## Welcome, Introductions, and Agenda

Kyle Clark, International Association of Chiefs of Police (IACP), introduced himself, welcomed participants to the Florida Impaired Driving Coalition (FIDC) meeting, and thanked everyone for joining. He facilitated a round of introductions, provided updates on the following items of interest happening nationally, and what they mean for impaired driving.

He said the Technical Advisory Panel of the IACP Enforcement Program is scheduled to meet on February 8<sup>th</sup> 2024. The panel aims to adopt a resolution on a uniform definition of Driving Under the Influence (DUI) that includes language referencing drug impaired driving. Additionally, the panel intends to support blood testing in fatal injury crashes.

Another item of national interest is a University of California San Diego road sobriety study that supports field sobriety tests as a useful tool utilized by highly trained law enforcement officers such as Drug Recognition Experts (DREs) to detect drug impaired driving. The California Department of Motor Vehicles, California Highway Patrol is partnering with UC San Diego in a follow up study. More information can be found at Research Project on Cannabis-Impaired Driving FAQs - California DMV. Kyle also noted that the National Highway Traffic Safety Administration (NHTSA) hosts the DRE data system and that efforts are being made to address DRE calculations for accuracy to ensure different drugs are classified correctly.

Kyle also provided relevant updates from an international perspective. He said the International Road Policing Alliance is a peer-to-peer organization that releases a monthly newsletter and is hosting the kickoff event for the IACP Impaired Driving and Traffic Safety (IDTS) conference on August 16-18, 2024 in Washington, DC. He cited the World Health Organization (WHO) saying that someone is killed in a traffic crash every 23 seconds and that the risk of death from a traffic crash is two and a half times greater than the risk of becoming a victim of violent crime. In Sweden, every patrol officer conducts traffic enforcement for at least twenty minutes of their shift and utilizes social media as an impact multiplier. Officers in Sweden focus on reducing speeding and impaired driving, which in turn has reduced other crime incidents. He said that the approach of every officer conducting some traffic enforcement rather than some officers only conducting traffic enforcement may be a strategy worth considering to elevate the participation and effectiveness of traffic safety enforcement.

In conclusion, Kyle emphasized the role of police in traffic safety, noting that driver behavior does not change unless consequences are swift and immediate, and that the effectiveness of automated enforcement where a ticket is sent in the mail after an infraction occurs may be limited in its effectiveness, if there is delay in the delivery of consequences.

Danny Shopf, Cambridge Systematics (CS), provided an overview of the coalition meeting agenda and the meeting followed.



## Office of Medical Marijuana Use (OMMU) Introduction

Chris Kimball, Director of the Office of Medical Marijuana Use (OMMU), presented on the OMMU. He provided his background and history as a law enforcement officer and prosecutor. He emphasized OMMU's focus on safety and communication. He emphasized that the safety of medical marijuana patients includes informed consent to abide by the law when utilizing public roadways, and that the concerns of increasing incidents of impairment from medical marijuana are shared by the OMMU. Additionally, he said that the utilization of telehealth services has expanded with the passage of HB 387 during the 2023 legislative session. HB 387 allows for medical marijuana prescriptions to be renewed via telehealth visits. In reference to concerns of increasingly potent strains, he said it is unlikely that product that is regulated by the Department of Health (DOH) would have a potency of over 15 percent tetrahydrocannabinol (THC), the psychoactive compound in marijuana. In addition, DOH displays how packaging should be plain, white, and opaque throughout their roadshows. Chris Kimball noted that the marijuana use registry is a useful tool for law enforcement to verify dosage, recent purchases, and potency of prescribed medical marijuana products.

Two major activities of the OMMU relate to FS 393 violations and the monitoring of the 25 companies providing patients care. When a 393 violation occurs, the OMMU immediately suspends a patient's card. The 25 companies that are authorized to grow, package, and sell medical marijuana support 871,459 patients and 2,781 qualified physicians prescribing medical marijuana. The overarching goal of the OMMU, companies, and recommending physicians is to provide safe care to patients. Relatedly, companies are required to ask permission to advertise and the public is encouraged to report instances of advertising that may be unpermitted. Chris noted that the OMMU does not regulate physicians, but does pursue stakeholder engagement opportunities and maintains open channels of communication with physicians. Due to this path of communication, a collaborative opportunity between the FIDC, OMMU, and physicians could be developed to distribute educational materials that combat drug impaired driving due to medical marijuana consumption. Chris noted that OMMU is meeting with the medical directors of the 25 companies in March and that the potential educational materials could present an opportunity for positive branding for them. Since roughly 1 million Floridians walk into dispensary to legally obtain medical marijuana, its important that safety is prioritized, especially given that in some dispensaries a culture that deviates from a medically focused purpose is marketed to patients. The OMMU supports information that promotes a culture of safety through education and looks forward to collaborating with the FIDC in the development and distribution of educational materials to reduce drug-impaired driving.

Participants had the following questions or comments:

- There are some instances where dispensaries have displayed product in mason jars.
  - OMMU stands by to assist law enforcement as well as States Attorneys in ensuring proper packaging and advertising compliance. Cannabis policy is complex, driving high is not.
- Melissa Gonzales, Florida Department of Highway Safety and Motor Vehicles (FLHSMV), asked if the OMMU regulates dispensary staff training?
  - The medical directors are statutorily required to train their employees and OMMU can provide suggestions.
- Ellen Snelling, Tampa Alcohol Coalition, noted that many medical marijuana patients received a recommendation for medical marijuana to treat broad conditions. She asked if OMMU or DOH can point



interested observers in the right direction for condition specific research supporting treatment with medical marijuana.

- The recommending doctors determine who are eligible to be patients and what dosage is appropriate. DOH values the physician and patient relationship and does not interfere in that relationship.
- Chris Earl, Florida Safety Council, asked if the OMMU regulates how close facilities owned by the 25 companies can be located to community facilities such as schools or parks?
  - Municipalities regulate them the same way they regulate pharmacies, however counties can wave those regulations.
- Ellen noted that there is legislation discussing possible restrictions on advertising medical marijuana in a
  way that suggests recreational usage, noting how some ads particularly on social media, can be
  perceived as more recreational than medical. She said she attended legislative committee hearings on
  industrial hemp in which the topic of medical marijuana came up frequently. She asked if the OMMU
  could participate in these hearings to share information?
  - Advertising presents a challenge. All advertising is required to be approved by the OMMU, however some pay the fine and continue using unapproved advertisements. Additionally, hemp is regulated by the Florda Department of Agriculture and Consumer Services (FDACS). Some legislators are investigating the extent to which intoxicating products can be derived from hemp. Medical marijuana in Florida has tougher testing requirements than other states with the goal to set up a framework to adhere to the law, while also acknowledging the uncertainty in this complex and changing landscape.
- Kyle noted that in obtaining certain prescriptions at a pharmacy, a one-on-one counseling session is required. He asked if there is anything similar in the medical marijuana space?
  - There is no requirement at the dispensing facility, however the qualified physician is required to conduct a full consultation to provide their best medical advice before recommending to a patient.
- Kristie Shaw, Florida Department of Law Enforcement (FDLE), emphasized the importance of education through sharing how a veteran friend of hers who is a patient did not receive any guidance from the dispensary.
  - It varies based on the physician, but the lack of guidance at the dispensing facility is a gap that could be an opportunity for educational materials development.
- Chris Craig, Florida Department of Transportation (FDOT), noted that the focus of the coalition and FDOT is with impaired driving. Does the OMMU have the ability to suggest displaying a sign educating the public about the dangers of impaired driving specific to medical marijuana in dispensaries, especially if the sign is provided at no charge to the dispensing facility?
  - Yes, OMMU is supportive of that collaboration and can suggest, but not require dispensing facilities to display such materials.



- Chris Craig said that the coalition could design a sign that is produced using federal grants funds that can then be provided as a free educational resource.
- Melissa asked how delivery to dispensaries of medical marijuana is regulated?
  - Drivers delivering medical marijuana undergo a background screening. Approximately 12,000
    people applied last year. Per statute, each delivery vehicle must have two people equipped with
    a detailed and specific manifest. Each vehicle is subject to audits and spot checks.
- Chris Earl asked if there is a limit on the number of licenses and where is the largest concentration of distribution?
  - There is not a limit on the number of licenses and the largest concentration of distribution centers is in Southeast and Southwest Florida.
- Kyle noted that in alcohol licensing there is a distinction between certain types of alcohol based on potency. Are there any plans or mechanisms through which the potency of medical marijuana can be regulated?
  - Not under current statutory authority. There will likely be a negotiated rulemaking process on potency, however that is likely to be focused on recreational marijuana in anticipation of a potential passage of the ballot initiative legalizing recreational marijuana. Additionally, in the interstate market there is not a cap on potency and there is a sizable data gap on the different potency levels available.
- How is banking conducted when cannabis is still federally illegal?
  - Banking is outside the purview of DOH and the focus of the OMMU.
- Ellen noted that in states where cannabis is legal, there have been attempts at capping potency at 30
  percent for flower and 60 percent for concentrate. However, these limits are only in place in a couple of
  states.
- Ellen asked if the seed-to-sail-verification system has started?
  - The state has procured a system and the industry will be expected to integrate with that system once a timeline is finalized.
- Ellen asked if there is demographic data on medical marijuana patients?
  - There is data, but few queries are run on the data that exists. Patients vary across age groups.
     That data could be useful in developing outreach and educational materials.



## FIDC Strategic Action Plan Subcommittee Breakout Overview

Danny provided an overview of the Subcommittee Breakout Sessions. The sessions consisted of one 45-minute discussion focused on key Impaired Driving Strategic Plan (ISDP) Actions. Coalition members divided into three groups based on the actions displayed on screen. He noted that CS staff will schedule and lead follow-up virtual meetings to support each subcommittees' progress in between the quarterly coalition meetings.

## FIDC Strategic Action Plan Subcommittee Breakout Session

Attendees joined into subcommittee groups based on the following Action Items:

- 1B.3 Develop a visual representation of Florida's full impaired driving countermeasures system
  which maps out what happens to someone when they receive a DUI (enforcement through
  treatment.)
- 3B.7 Review marijuana impairment communications conducted in peer states and develop an effective marijuana impairment campaign specific to Florida.
- 5A.1 Document 24/7 program best practices to develop a presentation which includes alcohol and other impairing substances for use in soliciting programs to participate in a Florida pilot.

## Survive the Ride Toxicology Analysis 2022

Dr. Patricia Byers presented on the results of a prospective toxicology analysis based on 2022 data to support the impaired motorcycling campaign, Survive the Ride.

She discussed the purpose and methods of the analysis. The analysis aimed to evaluate the prevalence of substance abuse in motorcycle crash victims by conducting a toxicological analysis of residual or discarded blood samples from motorcycle crash victims being treated at Ryder Trauma Center in Miami-Dade County to determine the presence of alcohol and/or illicit drugs. She said that for the purposes of the analysis, a log of the gender, age, and the date and time was the only identifying information obtained and documented.

Dr. Byers delved into the criteria for inclusion and exclusion within the study. Criteria focused on age, vehicle type, whether the patient was the driver, and pregnancy. Patients that were minors, elderly, not driving a motorcycle or scooter, was not the driver in the crash, or pregnant were not included in the study. 135 motorcycle or scooter crash patients were screened for inclusion between June 1, 2022 and September 20, 2022. Of those 135 patients, 104 were included with their blood samples being deidentified and collected for toxicology analysis.

The study attempted to answer the following questions:

- Does the type of vehicle used (motorcycle vs scooter) increase the frequency of crashes?
- Does patient demographics (gender/age) influence the type of vehicle involved in crash?
- What is the prevalence of alcohol/illicit substance use in motorcycle/scooter crash victims?
- Which drugs are most likely to be present in motorcycle/scooter crash victims?
- Is there a difference in prevalence of substance use in different age groups?



- Is there a difference in prevalence of substance use in different genders?
- Is the time of day a significant contributory factor in motorcycle/scooter crashes?
- Is the day of week a significant contributory factor in motorcycle/scooter crashes?

Next she shared the results of the toxicology analysis for alcohol, alcohol use by vehicle type, illicit drugs, and other drugs, as well as the results by age, gender, vehicle type, and time of day.

In conclusion she noted the following:

- The patient population was predominately male.
- Patients under the age of 50 were more likely to ride motorcycles compared to scooters.
   Additionally, these patients were also more likely to have had consumed alcohol and/or illicit drugs at the time of the crash.
- After alcohol, the top three illicit drugs found in patient blood samples were marijuana, cocaine, and fentanyl respectively. Additionally, the most frequent non-illicit drug was benzodiazepines.
- Patients who were involved in motorcycle crashes were more likely to have had positive toxicology tests for alcohol or illicit drugs than patients who were involved in scooter crashes.
- The time of day was not a statistically significant influence in overall frequency of motorcycle or scooter crashes. However, the presence of alcohol contributed to an in increase in nighttime crashes.

Dr. Byers stated the next steps as follows:

- Examine injury severity and cost of care for crashes with positive toxicology results compared to negative toxicology results
- Determine if there are crash hotspots in Miami-Dade County based on incidence
- Direct resources for law enforcement for identification of drivers under the influence

Participants had the following questions and comments:

- Tim Cornelius, Institute of Police Technology and Management (IPTM), asked Dr. Byers to clarify that all the samples analyzed were all derived from blood.
  - Yes, the samples used for the toxicological analysis were all derived from blood.
- Melissa asked if there was any indication what the injury severity was for each patient included in the analysis?
  - The initial research design did not include injury severity.
- Kyle asked what the percentage for alcohol and drugs detected?
  - o For patients under the age 50, alcohol and drugs was detected in 12.8 percent of patients.
- Kathleen Mazeek, FDLE Alcohol Testing Program, asked how much of illicit drugs detected in the samples is attributed to marijuana?



- THC was detected in 20 percent of the patient population. However, Dr. Byers noted that the
  analysis could not determine if marijuana was a factor in crashes, due to the extended period
  that THC is detectable compared to other substances.
- Chanyoung Lee, Center for Urban Transportation Research (CUTR), noted that there is a discrepancy between crash data systems.
  - o There is likely underreporting because of a backlog in toxicology reports.

## **DUI Diversion Program Fact Sheets**

Danny facilitated a discussion on a series of fact sheets intended to provide information on existing DUI Diversion Programs throughout Florida. He said that most of the coordination to develop the content in the fact sheets was undertaken by Vin Petty, Traffic Safety Resource Prosecutor (TSRP).

#### Participants had the following comments and questions:

 Chris Craig asked if the programs highlighted in the fact sheets reflect what is available throughout the state or reflect best practices for DUI Diversion Programs?



- The fact sheets reflect what is available throughout Florida, but is not comprehensive. Some State Attorney's Offices may have programs that aren't discussed here. What is available is also subject to legislative changes from year to year.
- Kyle noted that some Judicial Circuits include penalties while others do not. From an organization and formatting standpoint, having complete information would be ideal.
  - The content development process for the fact sheets varied across the judicial districts highlighted. Some were developed by what was publicly available online, others were based on content provided directly from each circuit, while others had not followed up providing those details.
- Kristie asked to clarify the intended audience.
  - The fact sheets are intended to be resources for anyone interested in the different components of the DUI countermeasure system in Florida.
- Melissa asked if there is documentation on best practices.
  - Yes, it is available on the FIDC website at <u>DUI Diversion Programs Suggested Best Practices</u>.

#### **Public Comment Period**

Larry Coggins, Mothers Against Drunk Driving (MADD), directed the coalition's attention to the Advanced Notice of Proposed Rulemaking announced by NHTSA to require technology to be included in new vehicles that would stop impaired, drowsy, and distracted driving. He noted that the only other instances of NHTSA undergoing a similar process in the past were for the inclusion of safety belts and for the inclusion of back-up cameras, underscoring the potential significance of this rulemaking activity He said that the deadline for comments is March 1<sup>st</sup>, 2024.

Chris Craig encouraged everyone to participate in the Triennial Highway Safety Plan Survey.

## Day 1 Recap

Danny and Kyle provided a quick recap of Day 1 of the meeting and reminded members that Day 2 would start at 9:00 AM the following morning.



# 3.0 Meeting Notes - February 2, 2024

## Recap of Day 1

Kyle welcomed participants and thanked them for attending Day 2 of the FIDC meeting. Kyle gave a detailed recap of Day 1 that included the following:

- Round of introductions
- Briefing on Technical Advisory Panel meeting
- Updates from the International Road Policing Alliance
- The OMMU regulates 25,618 distribution centers serving 871,000 patients. The coalition had a robust discussion of strategies to reduce drug induced driving from medical marijuana patients.
- Subcommittee breakout sessions focused on the DUI Countermeasure System Visualization, medical marijuana communication materials, and the 24/7 Pilot Program draft presentation.
- Survive the Ride Toxicology Analysis conducted between June and September of 2022 consisted of testing the blood samples for alcohol and illicit drugs in 104 patients receiving care from being in a crash while operating a motorcycle or scooter.
- DUI Fact Sheets Discussion
- Public comments included MADD referencing NHTSA's Advanced Notice of Proposed Rulemaking and FDOT encouraging members to take the <u>Triennial Highway Safety Plan Survey</u>.

## **FY24 FDOT Subgrants Presentation**

Chris Craig presented on the numerous subgrant activities awarded for Federal Fiscal Year 2024 (FY24) through the Annual Grant Application (AGA) process. He noted that one of them recommendations provided by NHTSA in the FIDC Assessment was to share the different subgrant activities with each of the FDOT Traffic Safety Coalitions.

He discussed the statewide fatal and serious injury crash trends with 3,555 fatal crashes and 15,988 serious injury crashes in 2022. He noted impaired driving consisted of approximately a third of statewide fatalities involving an impaired driver in 2022. Chris provided an overview of the different types of subgrant activities awarded for FY24 for the Impaired Driving Emphasis Area as listed below:

- Paid Media
- High Visibility Enforcement
- Traffic Safety Prosecutor Program
- Florida Impaired Driving Coalition
- Mothers Against Drunk Driving (MADD) Education and Florida Court Monitoring Program
- Public Traffic Safety Professional Trainings
- Drug Recognition Expert (DRE) Call-Out



After providing an overview of each type of subgrant, Chris discussed what FDOT can and cannot provide through subgrant funding. He highlighted the locations in the top 40 percent for fatalities and serious injuries based on the FY24 Highway Safety Matrix and encouraged participants to reach out to contacts in the highlighted counties, connect them with FDOT staff, and explore opportunities to apply for funding.

Participants had the following questions and comments:

- Kyle applauded the MADD Florida Court Monitoring program noting that there were several instances throughout the state that demonstrated this program's effectiveness.
- Mike Zinn, FDOT D7, asked if there will be a before and after study in jurisdictions where the court monitoring program is being conducted?
  - Larry said that the project is emulating the two most successful court monitoring programs located in South Carolina and New Mexico. The hope is that it will reduce recidivism and provide explanations why pursuit of DUI cases has dropped in some areas.
- Chris Craig noted that if this is demonstrates effectiveness there could be an opportunity to expand in future grant cycles.
- Danny asked if the long term vision for this program was for it to exist in each judicial circuit or in every county?
  - Larry said the focus is on the pilot project area, but noted that not all judicial circuits or counties need it.
- Melissa asked if a breathalyzer device equipped with facial recognition utilized during a 24/7 program would be allowed under subgrant funding?
  - That would be a new and unique device that NHTSA would need to provide guidance on before approving. Such devices may be more applicable to a 24/7 program then to an agency applying for enforcement funding.

## **Action Plan Report Out**

Danny Shopf, Cambridge Systematics, lead the coalition through a report out of the FIDC Strategic Action Plan.

He reminded the coalition that this is a five-year plan that progress will happen organically over time and that it is a living document subject to change. Sometimes actions change after every meeting, can be adjusted to actions and timelines. Important to know that this was written for five years horizon. Some of these items won't be visited for some time.

Action Step Leaders provided updates on their respective action steps.

## **Legislative Updates**

Chris Craig and Ernie Bradley, FDOT, opened the floor for discussion on legislative items moving through the 2024 Florida Legislative session. Larry provided an overview of items that MADD is tracking. He noted that <u>SB</u> <u>260</u>, which requires an ignition interlock device (IID) to be installed in the vehicle of a driver who refuses a breathalyzer, has passed all committees so far. If passed, updated implied consent materials should be developed. Implementation will likely happen between October 2024 and January 2025. Larry noted that



Florida's version of Bentley's Law, which would require child support payments to the children of parents in fatal injury crashes with someone convicted of DUI, will be discussed in its first committee on February 5, 2024. He shared that the model language change that would include "any and all drugs" to Florida's DUI law may not be prioritized this legislative session.

Ellen discussed her experience attending committee hearings for <u>HB 1613</u> and <u>SB 1698</u>, which would regulate hemp products.

#### **Public Comment Period**

There were no public comments.
