4. Qualifying CEU Activities and Assigned Credit Values

All CEUs must come from **ACLCA-recognized or ACLCA-sponsored activities** completed during the current certification cycle.

CLEs may select any combination of the following activities to meet the 12 CEU requirement.

- Participated in or overseen a project, initiative, or decision incorporating life cycle or sustainability principles — **2 CEUs per project** (max 6).
- Attended or presented at a professional sustainability or LCA-related event (e.g., **ACLCA conference, webinar, or workshop**) — **1 CEU per hour** of attendance; **3 CEUs per presentation**.
- Supervised, procured, or reviewed an LCA or environmental performance study within your organization or for a client — **2 CEUs per study**.
- Integrated life cycle thinking or sustainability metrics into organizational policy, purchasing, design, or strategy — **2 CEUs per initiative**.
- Mentored, trained, or educated others on sustainability, LCA, or related management concepts — **1 CEU per mentee or training session** (max 4).
- Published or contributed to sustainability-related guidance, reports, or standards — **3 CEUs per publication**.
- Served on an **ACLCA committee, task force, or working group** related to sustainability or life cycle practice — **1 CEU per year of service**.
