

Who can join: Open to all clients who purchase a Pacific Cross Travelsafe Insurance Plan through any of the following channels during the 2026 PTAA Travel Tour Expo:

- Manual issuance at the Pacific Cross booth
- Online issuance via the official e-commerce site for Pacific Cross Travelsafe insurance

How to join:

- Clients will receive raffle entries based on the plan purchased, as follows:

Plan Purchased	Raffle Entries
Multi-trip Plan	3 raffle entries
Asia & Oceania / Worldwide Elite	2 raffle entries
Domestic	1 raffle entry

- Physical stubs will not be issued. The Official Confirmation of Coverage (OCC) will serve as the raffle ticket for the draw.

For example, clients who purchase a Multi-Trip Plan will earn three (3) raffle tickets, while those with an Asia & Oceania or Worldwide Elite Plan will earn two (2) tickets. All tickets are linked to the OCC number issued at the time of purchase during the 2026 PTAA Travel Expo.

Terms & Conditions:

- All Official Confirmation of Coverage (OCC) issued and paid within the duration of the promo period are entitled to the raffle promo regardless of travel dates.
- The winner will be selected randomly from all eligible OCC numbers using the Pacific Cross Electronic Raffle tool.
