AGREEMENT TO OUR LEGAL TERMS

We are It Takes A Village To Feed One Child Inc., doing business as ITAVTFOC ("**Organization**," "**we**," "**us**," "**our**"), a 501(c)(3) nonprofit organization registered in Pennsylvania, United States, with our principal address at 112 Kearney Pl, Ridley Park, PA 19078.

We operate the website <https://www.itavtfoc.org> (the "**Site**"), the mobile application **ITAVTFOC** (the "**App**"), as well as any other related products and services that refer or link to these legal terms (the "**Legal Terms**") (collectively, the "**Services**").

ITAVTFOC is an app that facilitates donations, provides information about our mission, shares fundraising events, and offers opportunities to participate in auctions and ticketed events. Through ITAVTFOC, users can contribute to our cause, stay informed about initiatives, and engage with our community-driven efforts to support children in need.

These Legal Terms constitute a legally binding agreement made between you, whether personally or on behalf of an entity ("**you**"), and It Takes A Village To Feed One Child Inc., concerning your access to and use of the Services. Chargebacks & Payment Disputes
