## POOL RULES 2025

Springhurst Pool and Clubhouse is a private facility for the exclusive use of its members. Members and guests must adhere to all posted rules and regulations. These pool rules are in place to ensure the safety and enjoyment of all pool members and guests. They are not intended to be all-inclusive.

The lifeguard team, gate attendants and pool supervisor (pool staff) have the responsibility to enforce these rules and are in charge of the operation of the facility at all times. Their judgment is both necessary and expected. Disciplinary actions are at the sole discretion of the pool staff, including asking members to leave the facility. Should the pool staff judge any activity at the pool to be unacceptable for any reason, their decision is final. Repeated issues, upon review by the SCA Pool and Clubhouse Committee, may result in suspension of member privileges at the SCA Board's discretion.

Pool and Clubhouse members who are age six or older are required to have their photos taken for pool entry validation before entering the pool for the swim season. Each member aged 16 or older is required to show photo ID with a Springhurst address when the photo is taken. Members must display and scan their pool membership cards at the pool gate to gain admittance each time the pool area is entered. The gate attendant may ask to see a photo ID at any time.

Children under 11 years of age must be accompanied by a responsible person of at least 16 years of age. A photo ID with proof of age must be shown if requested. If supervision is judged by the pool staff to be inadequate to ensure the safety of the children, they will be asked to leave the facility.

Admission to the facility is refused to all persons having any contagious disease, infectious conditions such as colds, fever, ringworm, foot infections, skin lesions, carbuncles, boils, inflamed eyes, ear discharges, or any other condition which has the appearance of being infectious. Persons with excessive sunburn, abrasions which have not healed, corn plasters, bunion pads, adhesive tape, rubber bandages or other bandages of any kind are not permitted. A person under the influence of alcohol or exhibiting erratic behavior shall not be permitted in the facility area.

### MEMBERSHIP

1. A "household member" is a spouse, domestic partner, child, or other family member whose legal residence is in the member's home. A relative or friend visiting for the summer is not a household member for purposes of pool use. Likewise, a grandparent, cousin or other extended family member who does not reside in the home is not a household member. If a resident misuses a pool

membership card in this or any other capacity, the SCA Board maintains the right to suspend that member's family pool privileges for the remainder of the season.

2. Members who have not submitted a pool census form and paid all assessments and fees will NOT BE ADMITTED TO THE POOL. Forms and payments are required in the SCA Office at least two working days prior to use of the pool. Pool staff CANNOT ACCEPT FORMS AND PAYMENTS.
3. Entry will be validated at the pool desk utilizing the pool gate entry system.
4. Pool census forms, payments and proof of residency must be submitted to the SCA office. Pool staff may not accept forms and payments at the gate.

## **PASSES**

**Nanny Passes:** Pool and Clubhouse members may obtain a nanny pass from the SCA Office during regular office hours. Nanny pass holders are required to have photos taken for validation. Photo ID and proof of age (16 or older) are required. Passes will be specific to the pass holder and may be used only when caring for a member's child.

**Season Passes:** Pool and Clubhouse members may purchase a season pass for a child, grandchild, or grandparent who does not live in the household. The passes are \$40 per individual and may be purchased in the SCA Office during regular office hours. Each season pass will be specific to the pass holder and cannot be transferred or reassigned to another person. Season pass holders are required to have photos taken for validation. Season passes are only valid when the pass holder is accompanied by any Pool and Clubhouse member.

**Complimentary Guest Passes:** Each Pool and Clubhouse member household will receive **TEN** complimentary guest passes each pool season.

Daily Guest Fee: \$5 per guest (over 12 months of age)

EXCEPT \$7 per guest Holiday weekends (An additional \$2 must be paid at the gate.)

### **NEW FOR 2025**

Monday through Thursdays only (except Holiday Mondays) – Each household may bring two (2) guests free of charge per day.

### **Individual Guest Passes:**

Individual guest passes can be purchased in the SCA office or online via the QR code or link posted at the pool gate. Passes purchased online are \$6.25 each or \$43.00 for a virtual book of 10 passes due to fees charged by the processing company. Passes purchased in the SCA office are \$5.00 each or \$40.00 for a virtual book of 10 passes. An additional \$2.00 fee will be collected by the pool gate attendant on holiday weekends.

1. Passes (complimentary or purchased) have no cash value, and are not transferrable, and may not be carried over to the next pool season.
2. Guests over 12 months of age must be accompanied by a member and have a valid guest pass.
3. Holiday weekends are:
  - Memorial Day holiday weekend (Saturday, Sunday, AND Monday)
  - July 4<sup>th</sup> holiday or holiday weekend (dates posted on the bulletin board)
  - Labor Day holiday weekend (Saturday, Sunday, AND Monday)
4. The Maximum number of guests Monday through Thursday is seven (7) per household and five (5) on Fridays, weekends, and holidays.

5. The guest attendance at the pool is subject to the pool staff's discretion. Season pass holders are counted as guests. Guest policy is subject to change, WITH ONE WEEK'S POSTED NOTICE.

## **FOOD AND DRINK**

1. No glass or crystal-clear plastic containers of any type are allowed in the gated pool area.
2. The pool and clubhouse are non-smoking environments. Smoking AND VAPING are not allowed in the clubhouse or within the gated pool area.
3. The gas grilling center is available for use by members age 18 and over. Members are to sign out the grill key and user manual and maintain the grill and grill area in a neat and clean manner. The gas is to be shut off when cooking is complete. Please advise the pool staff if you find the tank low or empty.
4. Members may bring their own drinks and snacks to the pool.
5. Coolers and food are permitted within the gated pool area; however, all food and beverages must be in non-glass containers. Alcoholic beverages are permitted; however, any person exhibiting intoxication, using unacceptable or foul language, or otherwise exhibiting inappropriate behavior shall be asked to leave the facility immediately.
6. No drinks or food are allowed in the pool. No food is allowed within 5 feet of the pool's edge.
7. Members are always requested to police their immediate area and to throw all loose trash in the receptacles provided.

## **DIVING BOARD**

1. Diving in shallow water is not permitted. Goggles and flotation devices that do not have a strap that passes between the legs (like a life jacket or life vest) may not be worn when jumping off the diving boards. Swim cubes and water wings are not allowed to be used on the diving board.
2. Patrons must demonstrate their swimming ability before entering deep water if requested to do so by pool staff.
3. Only one person on the diving board at a time and only one person on the ladder at a time.
4. Patrons will observe distancing while waiting for turn on diving board.
5. Look before diving or jumping to make sure the diving area is clear.
6. Only one bounce is allowed on the diving board.
7. Dive or jump forward, straight out from the diving board.
8. Swim immediately to the closest ladder or wall.

## **EQUIPMENT AND FURNITURE**

1. Use of inflatable flotation devices must be approved by the pool staff upon entry. Multi-person floats / rafts are not permitted other than dive-in movies. The staff may ask that approved devices be removed at their discretion.
2. Battery operated water toys, water cannons and squirt guns of all sizes, hard flying discs, football, tennis, and golf balls, or any hard plastic toy, ball, or device deemed unsafe by the pool staff due to size or material is prohibited.
3. (Personal) noodles, kick boards, swim fins, and baby floats are allowed and not to be shared with non-family members.
4. Goggles, noodles, and other equipment will not be provided at the pool desk.
5. Walkway: A five-foot perimeter around the pool shall be kept free of obstruction.

Furniture and equipment not required for pool operation may not be placed in this walkway. The lifeguard chairs are an approved exception.

6. Basketball and basketball goal will be available when no more than 35 swimmers are IN the shallow end of the pool. Pool staff will utilize discretion to remove the ball if this results in dangerous or rough play at any time.
7. The pool staff's judgment in the areas of unacceptable items and unsafe play is final. Please always cooperate with their instructions for the safety and enjoyment of the facilities. Failure of guests and members to cooperate can result in immediate removal from the facility and/or suspension / restriction of pool privileges.
8. Chairs and chaise lounges are for use on a first come, first served basis and are not to be saved for others not in attendance.
9. No outside furniture is permitted within the fenced area of the pool except as follows: Memorial Day weekend, Labor Day weekend, and the 4th of July holiday. When the 4th falls on a weekend, Friday, or Monday, the exception will also apply to that holiday weekend. Folding chairs only are allowed, and must be placed on the aggregate patio and NOT on the pool deck.
10. There is no Lost and Found. If you leave it, you lose it. All property remaining will be discarded daily.
11. No toys, goggles, noodles, or floats of any kind will be stored in the Staff Room. The Staff Room is for STAFF only.

#### **EVERYTHING ELSE**

1. The wading pool is for use by children under the height of 36". A responsible adult must accompany the children inside the wading pool enclosure and must actively supervise children at all times while in the wading pool and enclosure.
2. Children who are not toilet-trained must wear swim diapers.
3. Swimmers must wear family-appropriate swimwear.
4. Hand sanitizer will be provided at the pool desk and in restrooms.
5. Spitting, spouting water, blowing the nose, or otherwise introducing contaminants into the facility water is not permitted. Health Department regulations require that discharge of any type of body fluid in the pool be immediately reported to the pool staff so that appropriate cleaning actions can be undertaken. This includes any unintentional discharges in the pools or restroom areas.
6. Personal conduct within the facility shall ensure that the safety of self and others is not jeopardized. No running and no serious or rough play (except supervised water sports) are permitted.
7. If the pool staff receives a complaint of any kind regarding music or sound, they will require the device to be turned down, turned off, or listened to through headphones only.
8. Safety breaks - Once every hour the pool will be cleared for a period of ten minutes of all patrons except patrons aged 18 and older and parents with babies-in-arms under one year old. Two lifeguards will remain on duty any time there are patrons in the pool.
9. Thunder and lightning - At the first sound of thunder or sighting of lightning, immediately leave the pool area and move to a safe place. Do not use the pool area until 30 minutes have passed after a thunder or lightning event.
10. The bulletin board on the pool porch is limited to posting official pool announcements and menus for restaurants that deliver to the Springhurst pool. Deliveries must be made to pool desk.
11. Parking in front of the clubhouse is reserved for clubhouse meeting and rental usage only, and

is not permitted for those members using the pool. Violators may be towed. The handicap spaces are available for appropriately tagged vehicles.

12. Animals shall be excluded from the facility area.
13. Pool hours, capacity, length of sessions, and other changes may be made as necessary.
14. **Register your email address to be advised of any changes.**

**MEMBERS WHO DO NOT OBSERVE THE RULES  
WILL BE REQUIRED TO LEAVE THE POOL IMMEDIATELY**

**Don't Be Delayed or Denied Pool Entry!**

1. Complete your census form, sign and return it to the SCA Property Manager. (This is required even if you were a pool and clubhouse member in the past.)
2. Pay all association and member assessments. *The pool staff cannot accept payment and census forms.* Please contact the SCA Office during regular office hours.
3. Full payment of all homeowner account balances and your census form must be received to enter the pool facility. There are no exceptions.
