### 1. About the Website

Please read these terms and conditions (Terms) carefully. By using, browsing and/or reading the Website, this signifies that you have read, understood and agree to be bound by the Terms. If you do not agree with the Terms, you must cease usage of the Website, or any of Services, immediately.
- (c) Intellifold Process Mining Operations Pty Ltd reserves the right to review and change any of the Terms by updating this page at its sole discretion. When Intellifold Process Mining Operations Pty Ltd updates the Terms, it will use reasonable endeavours to provide you with notice of updates to the Terms. Any changes to the Terms take immediate effect from the date of their publication. Before you continue, we recommend you keep a copy of the Terms for your records.

## 2. Acceptance of the Terms

You accept the Terms by remaining on the Website. Where the option is available in the user interface, you may also accept the Terms by clicking to accept or agree to the Terms.

### 3. About the Service

- (a) Process Mining Solution Services is an environment hosted by Intellifold Process Mining Operations Pty Ltd with applications and solutions for business engagement and demo purposes. These applications and solutions use business or demo data, presented for user interaction via automatically generated process flows and dashboards to enable process and data insights and drive business improvement.
- (b) Display, Developer, and User Administration accounts are currently offered. You acknowledge and agree that the accounts offered, as well as the account features may change from time to time and may be governed by separate terms which apply specifically to the account. Where special account-specific terms apply, you will be informed, and must accept those terms before you are given such an account. For the avoidance of doubt these Terms apply unless otherwise agreed or amended by account-specific terms.
- (c) Some accounts may be governed by a separate Software Licensing Agreement with Intellifold Process Mining Operations Pty Ltd, which may amend the terms of use. For the



avoidance of doubt these Terms apply unless otherwise agreed or amended by the terms of an applicable Software Licensing Agreement.

# 4. Acceptable use of the Service

- (a) Process Mining Solution Services, its related features, and website must only be used lawfully. Intellifold Process Mining Operations Pty Ltd reserves the right to suspend, cancel, or otherwise deny access to users and accounts who use the service:

- (c) To stalk, harass or threaten users and any member of the public.

# 13. Termination of Contract

  - (ii) providing Intellifold Process Mining Operations Pty Ltd with 10 working days' notice of your intention to terminate; and

- (c) Any notices pursuant to Clause 13.2 above should be sent, in writing, to Intellifold Process Mining Operations Pty Ltd via the 'Contact Us' link on our homepage.
- (d) Intellifold Process Mining Operations Pty Ltd may at any time, terminate the Terms with you if:
  - (i) you do not renew the Subscription at the end of the Subscription Period;
  - (ii) you have breached any provision of the Terms or intend to breach any provision;
  - (iii) Intellifold Process Mining Operations Pty Ltd is required to do so by law;
  - (iv) the provision of the Services to you by Intellifold Process Mining Operations Pty Ltd is, in the opinion of Intellifold Process Mining Operations Pty Ltd, no longer commercially viable.
- (e) Subject to local applicable laws, Intellifold Process Mining Operations Pty Ltd reserves the right to discontinue or cancel your Subscription or Account at any time and may suspend or deny, in its sole discretion, your access to all or any portion of the Website or the Services without notice if you breach any provision of the Terms or any applicable law or if your conduct impacts Intellifold Process Mining Operations Pty Ltd's name or reputation or violates the rights of those of another party.

# 14. Indemnity

# 15. Dispute Resolution

# 15.1. Compulsory:



If a dispute arises out of or relates to the Terms, either party may not commence any Tribunal or Court proceedings in relation to the dispute, unless the following clauses have been complied with (except where urgent interlocutory relief is sought).

### 15.2. Notice:

A party to the Terms claiming a dispute (**Dispute**) has arisen under the Terms, must give written notice to the other party detailing the nature of the dispute, the desired outcome and the action required to settle the Dispute.

#### 15.3. Resolution:

On receipt of that notice (**Notice**) by that other party, the parties to the Terms (**Parties**) must:

- (a) Within 28 days of the Notice endeavour in good faith to resolve the Dispute expeditiously by negotiation or such other means upon which they may mutually agree;
- (b) If for any reason whatsoever, 28 days after the date of the Notice, the Dispute has not been resolved, the Parties must either agree upon selection of a mediator or request that an appropriate mediator be appointed by a member of the Mediator Standard Board (<a href="https://msb.org.au/msb-member-list">https://msb.org.au/msb-member-list</a>) as selected by Intellifold Process Mining Operations Pty Ltd. Disputes are to be resolved in accordance with the rules of the Australian Centre for International Commercial Arbitration (<a href="https://acica.org.au">https://acica.org.au</a>);
- (c) The Parties are equally liable for the fees and reasonable expenses of a mediator and the cost of the venue of the mediation and without limiting the foregoing undertake to pay any amounts requested by the mediator as a precondition to the mediation commencing. The Parties must each pay their own costs associated with the mediation;
- (d) The mediation will be held in Sydney, Australia.

#### 15.4. Confidential

All communications concerning negotiations made by the Parties arising out of and in connection with this dispute resolution clause are confidential and to the extent possible, must be treated as "without prejudice" negotiations for the purpose of applicable laws of evidence.

### 15.5. Termination of Mediation:

If 2 months have elapsed after the start of a mediation of the Dispute and the Dispute has not been resolved, either Party may ask the mediator to terminate the mediation, and the mediator must do so.

# 16. Venue and Jurisdiction



The Services offered by Intellifold Process Mining Operations Pty Ltd is intended to be viewed by residents of Australia. In the event of any dispute arising out of or in relation to the Website, you agree that the exclusive venue for resolving any dispute shall be in the courts of New South Wales.

# 17. Governing Law

The Terms are governed by the laws of New South Wales. Any dispute, controversy, proceeding or claim of whatever nature arising out of or in any way relating to the Terms and the rights created hereby shall be governed, interpreted and construed by, under and pursuant to the laws of New South Wales, Australia without reference to conflict of law principles, notwithstanding mandatory rules. The validity of this governing law clause is not contested. The Terms shall be binding to the benefit of the parties hereto and their successors and assigns.

#### 18. Severance

If any part of these Terms is found to be void or unenforceable by a Court of competent jurisdiction, that part shall be severed, and the rest of the Terms shall remain in force.
