## 1. Data Controller

### 2. Personal Data We Collect

We process the following categories of personal data, depending on how you interact with us:

# A. When you contact us (email or contact form):

- Name
- Email address
- Phone number (if provided)
- Content of your message

## B. When you register for an expedition:

- Name, address, country of residence
- Email address and phone number
- Emergency contact details (ICE)
- Passport/ID information (if needed for logistics or local tourist registration)
- Health-related information voluntarily provided for safety purposes
- Dietary preferences or restrictions
- Payment information (via invoice)

#### C. When you sign up for the newsletter:

- Name
- Email address
- Consent timestamp

## D. When you visit our website:

We only use essential technical cookies; we do not track users for advertising purposes.

#### E. Photo and video material:

- Photos or videos taken during expeditions or events
- Only a limited amount of photo or video material is made during our expeditions, but participants should be aware that it may occur (see section 5)

# 3. Legal Basis for Processing

We process personal data based on the following legal grounds:



#### **Contractual necessity**

For expedition registration and participation.

### Legitimate interest

To communicate with you after you contact us voluntarily.

#### Consent

For:

- Newsletter subscriptions
- Use of photo/video material where required
- Sensitive data such as health information

#### Legal obligation

For accounting and invoicing purposes.

#### 4. How We Use Personal Data

### A. To organize and run expeditions

- Registration and administration
- Safety management and emergency procedures
- Sharing necessary information with facilitators, guides, and mountain partners
- Communication before, during, and after the expedition

### B. To respond to your inquiries

When you contact us directly.

#### C. To send newsletters

Only when you give explicit consent (opt-in).

Every newsletter includes a simple unsubscribe option.

#### D. For accounting and administration

In accordance with Italian and EU law.

#### E. For photos and videos

See next section.

## 5. Use of Photos & Videos

During expeditions, photos or videos may occasionally be taken for:

- internal documentation
- sharing memories with participants
- website or social media content
- promotional materials related to OTRO Elements

### We respect your privacy:

Participants are informed before and during the expedition

You may object at any time

- If you do not wish to appear in photos or videos, inform us verbally or in writing
- We will respect your choice and exclude/remove images accordingly

We do not publish images in a way that identifies individuals without a clear purpose or without respecting objections.

## 6. Newsletter Communication

You will only receive newsletters if:

- you explicitly subscribe via our website,
- or you check the newsletter opt-in on the expedition registration form,
- or you check the newsletter opt-in on the contact form.

We do not add people automatically to the newsletter list.



Unsubscribing is possible at any moment via the link in every email.

# 7. Sharing of Personal Data

We only share your data with:

- Expedition facilitators or guides (only what is necessary)
- Logistics partners (e.g., accommodation, transport providers)
- Local tourist registration
- Accounting systems and legal authorities when required

We do not sell or rent personal data to third parties.

# 8. Storage Duration

We retain data only as long as necessary:

- Expedition administration: 5 years
- Accounting data: 10 years (legal requirement)
- Newsletter data: until you unsubscribe
- Contact form messages: 12 months
- Photo/video material: until we no longer use it, unless you request removal

# 9. Security Measures

We take appropriate technical and organizational measures to protect your data from:

- unauthorized access
- loss
- misuse
- alteration

# 10. Your Rights Under GDPR

You have the right to:

- access your data
- correct inaccurate data
- request deletion ("right to be forgotten")
- withdraw consent at any time
- restrict processing
- object to processing
- request a copy of your data (data portability)
