

## 香港室內設計協會 - 會員類別

### 全權會員

全權會員必須持有香港永久性居民身份證，以及符合以下任何一項資格：

1. 畢業於協會認可的室內設計/室內建築/建築課程（最少兩年全日制課程），最少兩年專業工作經驗，或
2. 最少五年的室內設計/室內設計/室內建築的實際專業經驗。

### 企業會員

企業會員包括在香港從事室內設計業務最少三年的企業及不限於室內設計/建築設計公司、供應商、承辦商、及其他相關業務的企業。企業會員可以任命及登記兩名代表參與本會之活動。

### 教育機構會員

教育機構會員必須是教育機構並由香港室內設計協會董事會邀請加入。這些教育機構必須是教授室內設計/室內建築/建築學的認可機構。

### 非本地會員

非本地會員包括非居住香港人士，以及符合以下任何一項資格：

1. 畢業於協會認可的室內設計/室內建築/建築課程（最少兩年全日制課程），最少兩年專業工作經驗，或
2. 最少五年的室內設計工作/室內設計/室內建築的實際專業經驗。

### 畢業會員

畢業會員包括人士畢業於本會認可之室內設計/室內建築設計/建築設計課程。畢業會籍最多兩年。

### 學生會員

學生會員必須在香港就讀於本會認可之學院，並主修室內設計/室內建築設計的全日制註冊學生。其學生會籍會於畢業時自動失效，屆時可申請成為畢業會員，費用全免。

備註：以上會員類別，只有全權會員於會員大會擁有投票權。

## 認證室內設計師 (HKIDA)

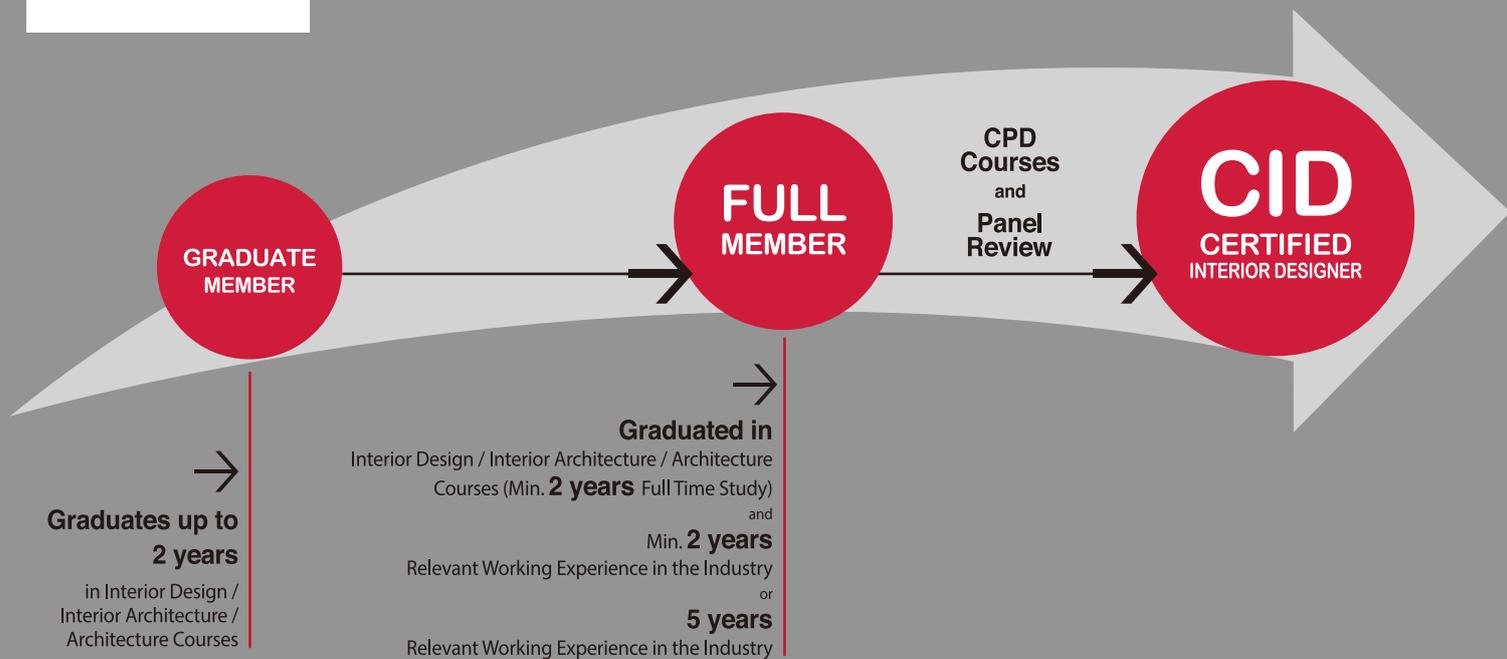
香港室內設計協會是香港首個室內設計協會授予認證室內設計師，目的為推動及提升香港室內設計行業的專業性。

## Hong Kong Interior Design Association (HKIDA) Classification of Membership

### Full Member

Holders of Hong Kong Permanent Identity Card, together with any of the following qualifications:

1. Graduated in Interior design / Interior Architecture / Architecture courses (Minimum 2 years full time study) approved by the Association with minimum 2 years experience, OR
2. Minimum 5 years interior design working/ practical professional experience in interior design / interior architecture.

### Corporate Member

Corporations or firms holding an interior design practice in Hong Kong at least 3 years or corporations or firms carrying business of interior design, suppliers, contractors and any other business related to interior design. A Corporate Member may nominate and register up to two nominees to participate activities organized by the Association.

### Institutional Member

Educational institutions invited by the Board of Directors to join HKIDA as an Institutional Member. Such educational institutions must be recognized institutions teaching Interior design / Interior Architecture/ Architecture.

### Non-local Member

Persons resided outside Hong Kong, together with any of the following qualifications:

1. Graduated in Interior design / Interior Architecture / Architecture courses (Minimum 2 years full time study) approved by the Association with minimum 2 years experience, OR
2. Minimum 5 years interior design working/ practical professional experience in interior design / interior architecture.

### Graduate Member

Persons who are graduates up to 2 years in Interior design / Interior Architecture / Architecture courses recognized by the Association.

### Student Member

Registered students in Hong Kong, studying full time in a recognized institution with a major in interior design / interior architecture. Their memberships will automatically expire upon their graduation and they may apply to become Graduated Members free of charge.

Remarks: Among the above membership categories, only Full Members have voting rights at General Meetings.
