# PLYRS CRCL – Agent Terms of Service

Welcome to PLYRS CRCL, the exclusive, members-only platform connecting professional footballers with vetted, high-integrity service providers. By onboarding as an Agent, you agree to the following Terms of Service:

## 1. Eligibility & Verification

To be accepted as an Agent on PLYRS CRCL, you must:

- Be a licensed intermediary or agent in accordance with FIFA or relevant national football association regulations.
- Pass our vetting and background verification process.
- Agree to adhere to PLYRS CRCL's Code of Conduct and Code of Ethics at all times.

We reserve the right to reject, suspend, or remove any agent who fails to meet these standards.

## 2. Exclusivity & Conduct

Agents must conduct themselves with professionalism, honesty, and transparency.

You agree not to:

- Misrepresent your credentials, relationships, or clients.
- Engage in poaching, unethical practices, or illegal activity.
- Circumvent the platform to work with players outside of PLYRS CRCL (see Section 6).

Agents are expected to act in the best interests of the player at all times.

### 3. Subscription & Tier Access

All agents are subject to a monthly subscription based on selected tier:

Pro Tier: £150/monthPro+ Tier: £275/month

• Elite Tier (Invite Only): £475/month

Minimum commitment term: 12 months.

Cancellation must be given with 30 days' notice.

Failure to pay may result in suspension or permanent removal from the platform.

### 4. Messaging & Introductions

All communications between agents and players must occur within the platform.

Agents may not initiate off-platform contact unless:

- Approved by PLYRS CRCL, and
- Acknowledged by the player via platform messaging.

This ensures player safety, audit trails, and legal protection for all parties.

#### 5. Commission & Fees

If an agent secures a deal or agreement via a PLYRS CRCL connection (e.g. brand deal, club transfer, service agreement), PLYRS CRCL may receive a commission.

Commission structure to be outlined in a separate Commission Agreement, or case-by-case basis.

All invoicing must go through the platform.

#### 6. Non-Circumvention

Agents agree not to circumvent the platform by:

- Contacting, working with, or onboarding players met through PLYRS CRCL off platform.
- Facilitating deals or introductions outside the system to avoid commission or platform fees.

Breach of this clause may result in:

- Immediate removal
- Legal action
- Lifetime ban from the platform

### 7. Confidentiality

Agents agree to maintain strict confidentiality regarding:

- Player information
- Platform content
- Internal communications

Disclosure of any sensitive or personal data will result in immediate termination and potential legal consequences.

#### 8. Termination

PLYRS CRCL reserves the right to suspend or terminate access if any terms are breached. Agents may also terminate their subscription by providing 30 days' written notice after the minimum term.

## 9. Legal & Liability

Agents are responsible for their own legal compliance and licensing obligations.

PLYRS CRCL accepts no liability for actions taken by agents outside of our platform.

- 5. I accept the platform's right to suspend, review or terminate my listing for any breach of terms.
- 6. I understand that all invoices relating to player services must be processed through the platform.
